#### **PUBLIC PATH EXTINGUISHMENT ORDER 2025**

On 3 June 2025 Lincolnshire County Council confirmed the above-named Order. The effect of the Order as confirmed is to extinguish the whole width of Public Footpath 1 in the parish of North Hykeham commencing on the southwest boundary of 10 Russell Avenue at Ordnance Survey Grid Reference SK 9445 6547 (A), running in a south south westerly direction over a scrub field for approximately 112 metres to OSGR SK 9438 6538 (B). Here it turns in a generally west south westerly direction across a grassed area for approximately 152 metres to join the unaffected part of Public Footpath 1 at OSGR SK 9425 6530 (C). The total length of extinguished footpath is approximately 264 metres as shown between points A-B-C on Order plan numbered 2024/020/PPO384/A4.

The Order comes into force as from 1 July 2025 but if a person aggrieved by the Order desires to question its validity, or of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within six weeks from 26 June 2025 make an application to the High Court.


## **EXTINGUISHMENT OF PART OF NORTH HYKEHAM PUBLIC FOOTPATH 1**

The whole width of Public Footpath 1 commencing on the southwest boundary of 10 Russell Avenue at Ordnance Survey Grid Reference SK 9445 6547 (A), running in a south south westerly direction over a scrub field for approximately 112 metres to OSGR SK 9438 6538 (B). Here it turns in a generally west south westerly direction across a grassed area for approximately 152 metres to join the unaffected part of Public Footpath 1 at OSGR SK 9425 6530 (C). The total length of extinguished footpath is approximately 264 metres as shown between points A-B-C on annexed plan numbered 2024/020/PPO384/A4.
