The effect of the Order as confirmed is to extinguish the full width of Restricted Byway 1125 in the parish of Woodhall Spa commencing on the western side of the former railway on the river Witham's eastern bank at Ordnance Survey Grid Reference TF 1750 6239 (A), running in a generally east north easterly direction over a grass field for approximately 30 metres to OSGR TF 1753 6241 (B). Here it turns in a generally north easterly direction for approximately 53 metres to OSGR TF 1756 6245 (C). Here it joins a track on the northern side of the ditch, along which it continues in a generally east north easterly direction for approximately 157 metres to OSGR TF 1772 6249 (D). The way then crosses the property 59 Mill Lane in a generally east north easterly direction for approximately 42 metres until it meets the public highway Mill Lane at OSGR TF 1776 6250 (E). The total length of extinguished footpath is approximately 282 metres as shown between points A-B-C-D-E on Order drawing numbered 2022/013/PPO376/A4.




