

ROAD TRAFFIC REGULATION ACT 1984

LINCOLNSHIRE COUNTY COUNCIL

(SPALDING – VARIOUS ROADS)

(PROHIBITION OF WAITING) AMENDMENT ORDER 20

THE LINCOLNSHIRE COUNTY COUNCIL in exercise of its powers under Sections 1, 2(1) and (2), 3, 4, 5, 32, 35, 45, 46, 49, 53, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and the Traffic Management Act 2004 (the Act of 2004) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This Order shall come into operation on 20 and may be cited as the Lincolnshire County Council (Spalding – Various Roads) (Prohibition of Waiting) Amendment Order 20
2. The Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 Plans including the key (the 'Plans') are incorporated into this Order.
3. Plan ? of the Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 shall be amended.
4. Any restriction or requirement made or having effect as if made under the Act of 1984 or any other enactment is hereby revoked insofar as it relates to the length and sides of road specified in this Order.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

STATEMENT OF REASONS

- Lincolnshire County Council recently received a request to review the waiting restrictions in the vicinity of Balmoral Avenue to the rear of the Primary School.
- Advisory School Keep Clear markings have recently been installed; however, investigations have shown that these markings are not always adhered to, and inconsiderate and dangerous parking is also occurring on the bend and at the junctions close to the school causing safety concerns for all road users.
- It is therefore proposed to make the School Keep Clear markings mandatory between the hours of 8 to 9.30am and 2.30 to 4pm, Monday to Friday, with no waiting at these times in locations where parking at peak times disrupts traffic flow and impedes visibility.
- No Waiting at Any Time restrictions are also proposed on the surrounding junctions to ensure visibility is maintained.
- Therefore, it is proposed to prohibit waiting as set out on the plans to the Order.
- The Chief Constable and South Holland District Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting on Balmoral Avenue and the surrounding area to the rear of the Primary School as set out in the Schedule below.

- School Keep Clear markings to become mandatory between the hours of 8 to 9.30am and 2.30 to 4pm, Monday to Friday.
- No Waiting between the hours of 8 to 9.30am and 2.30 to 4pm, Monday to Friday at various locations to enable traffic flow.
- No Waiting at Any Time on the surrounding junctions to ensure visibility is maintained.

Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
