

ROAD TRAFFIC REGULATION ACT 1984

LINCOLNSHIRE COUNTY COUNCIL

(BINBROOK - ORFORD ROAD)

(PROHIBITION OF WAITING) AMENDMENT ORDER 2025

THE LINCOLNSHIRE COUNTY COUNCIL in exercise of its powers under Sections 1, 2(1) and (2), 3, 4, 5, 32, 35, 45, 46, 49, 53, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and the Traffic Management Act 2004 (the Act of 2004) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This Order shall come into operation on 2025 and may be cited as the Lincolnshire County Council (Binbrook - Orford Road) (Prohibition of Waiting) Amendment Order 2025
2. The Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 Plans including the key (the 'Plans') are incorporated into this Order.
3. Plan 7 of the Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 shall be amended.
4. Any restriction or requirement made or having effect as if made under the Act of 1984 or any other enactment is hereby revoked insofar as it relates to the length and sides of road specified in this Order.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

STATEMENT OF REASONS

- Investigations have shown that although the advisory zig-zag markings are generally adhered to, they are not placed in the most suitable locations and they do not meet the required standard as per the regulations.
- It is proposed to relocate the markings and make them mandatory to prevent parking on them at peak times. A bus stand is also proposed to ensure the school transport service can operate safely.
- No waiting at Any Time is also proposed at the junction of Orford Road/Kirmond Road to maintain visibility and prevent parking on the bend.
- Therefore, it is proposed to prohibit waiting as set out on the plans to the Order.
- The Chief Constable, Binbrook Parish Council, and East Lindsey District Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to introduce;

Mandatory school keep clear markings outside Binbrook Primary School Monday to Friday, 8am to 9:30am and 2:30pm to 4pm. Proposed No Waiting at Any Time near the junction of Kirmond Road and Orford Road, and near the staff entrance for the primary school. To introduce a bus stand enforceable from Monday to Friday, 8am to 9:30am and 2:30pm-4pm.


Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
