

ROAD TRAFFIC REGULATION ACT 1984

LINCOLNSHIRE COUNTY COUNCIL

(LINCOLN-BURTON ROAD)

(PROHIBITION OF WAITING) AMENDMENT ORDER 2025

THE LINCOLNSHIRE COUNTY COUNCIL in exercise of its powers under Sections 1, 2(1) and (2), 3, 4, 5, 32, 35, 45, 46, 49, 53, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and the Traffic Management Act 2004 (the Act of 2004) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This Order shall come into operation on 2025 and may be cited as the Lincolnshire County Council (Lincoln-Burton Road) (Prohibition of Waiting) Amendment Order 20
2. The Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 Plans including the key (the 'Plans') are incorporated into this Order.
3. Plan 2 of the Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 shall be amended.
4. Any restriction or requirement made or having effect as if made under the Act of 1984 or any other enactment is hereby revoked insofar as it relates to the length and sides of road specified in this Order.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

STATEMENT OF REASONS

- Investigations have shown that the existing bus stop on Burton Road outside property numbers 174-180, is currently positioned between parking bays, and when these are in use buses are unable to pull into it to access the kerbside and overhang into the carriageway causing obstruction to traffic flow.
- It is therefore proposed to relocate the bus stop further south fronting numbers 162-166 Burton Road and extend the residents permit parking bay where the existing bus stop is currently situated. The proposed restrictions will improve the flow of traffic in the area and will aid visibility and safety for all road users.
- Therefore, it is proposed to prohibit waiting as set out on the plan to the Order.
- The Chief Constable, and City of Lincoln Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to:

- Introduce a Bus Stop Clearway Mon-Sat 6am-Midnight and Sunday 7:30am-7pm outside 162-166 Burton Road (even numbered properties).
- Introduce resident parking bays Mon-Sat 8am-6pm outside 174-180 Burton Road (even numbered properties).


Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
