- This Order may be cited as the Lincolnshire County Council (Ingham, Stow Lane & Lincoln Road) (30mph Speed Limit) Order 20 and shall come into operation on 20.
- 2. No person shall drive any motor vehicle at a speed exceeding 30mph on the length of road specified in the Schedule to this Order.
- 3. No speed limit imposed by this Order applies to vehicles falling within regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3 (5) of those regulations.
