

ROAD TRAFFIC REGULATION ACT 1984
LINCOLNSHIRE COUNTY COUNCIL
(CROWLAND, NORTH STREET & WEST STREET)
(PROHIBITION OF WAITING) AMENDMENT ORDER 20

THE LINCOLNSHIRE COUNTY COUNCIL in exercise of its powers under Sections 1, 2(1) and (2), 3, 4, 5, 32, 35, 45, 46, 49, 53,124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and the Traffic Management Act 2004 (the Act of 2004) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This Order shall come into operation on _____ 20__ and may be cited as the Lincolnshire County Council (Crowland, North Street & West Street) (Prohibition of Waiting) Amendment Order 20
2. The Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 Plans including the key (the 'Plans') are incorporated into this Order.
3. Plan ? of the Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 shall be amended.
4. Any restriction or requirement made or having effect as if made under the Act of 1984 or any other enactment is hereby revoked insofar as it relates to the length and sides of road specified in this Order.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

STATEMENT OF REASONS

- Site investigations have found that vehicles are parking in the existing bays for extended periods of time. Following local representations, we are proposing to introduce 2 hours Limited Waiting Monday to Saturday 10am to 6pm, No Return Within 1 hour, on the easterly side of North Street.
- Also, on the south side of West Street, we are proposing to introduce a length of 1 hour Limited Waiting Monday to Saturday 8am to 6pm, No Return Within 1 Hour, as well as a short extension to the No Waiting At Any Time restriction which will cover an existing access.
- These proposals are intended to maintain turnover of vehicles outside the local shops and facilities.
- Finally, we are also proposing to modify the existing Disabled parking areas on both North Street and West Street to make them operative every day of the week as opposed to the current Monday to Saturday.
- Therefore, it is proposed to limit and prohibit waiting as set out on the plans to the Order.
- The Chief Constable, Crowland Parish Council and South Holland District Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to introduce the following:

- 2 hours Limited Waiting Monday to Saturday 10am to 6pm, No Return Within 1 hour, on the easterly side of North Street, Crowland.
- 1 hour Limited Waiting Monday to Saturday 8am to 6pm, No Return Within 1 Hour in the vicinity of properties 6-10 and No Waiting At Any Time in the vicinity of property number 2 and the adjacent access on West Street, Crowland.
- Change the days on the existing disabled parking bays on North Street and West Street so they are operative Monday – Sunday.

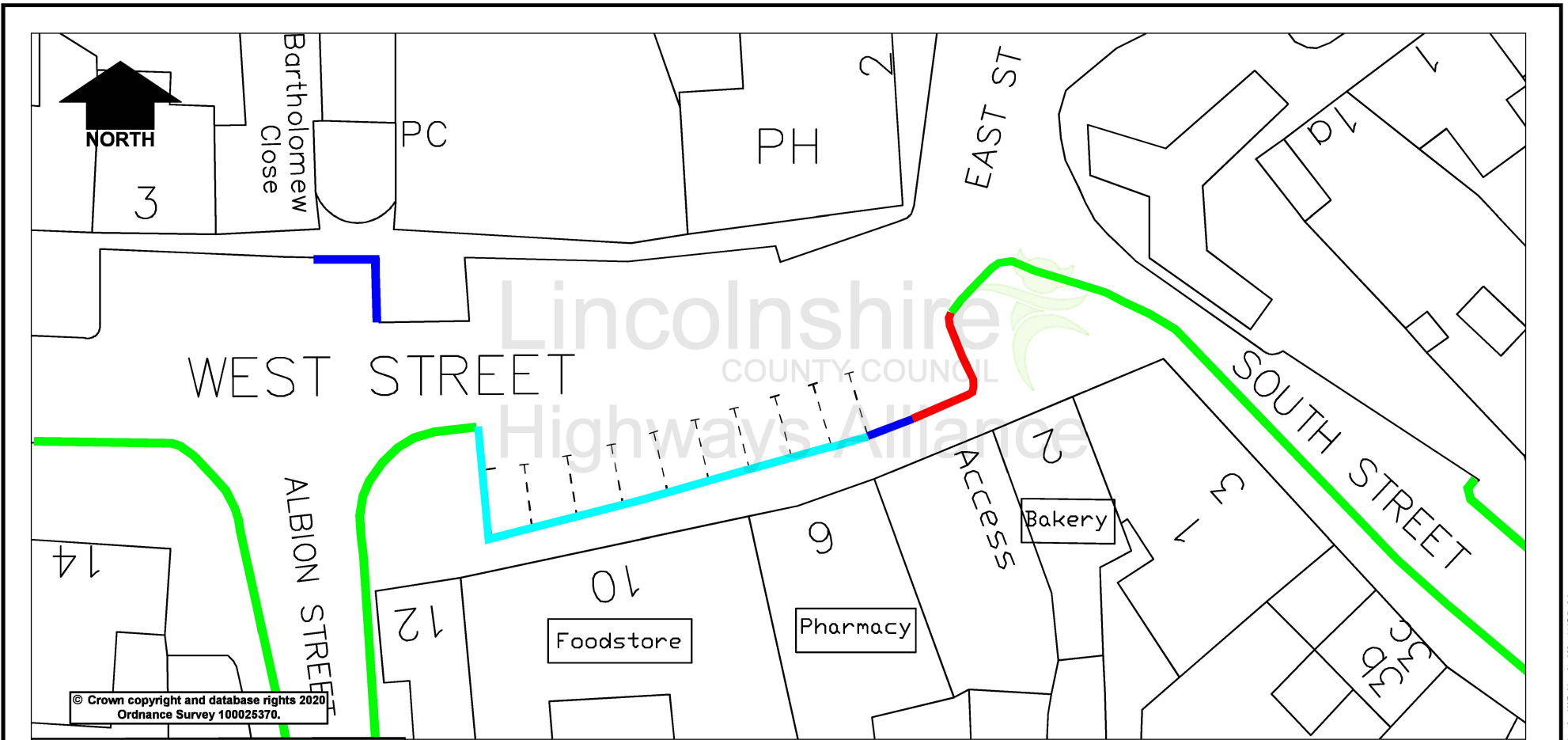
Some exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.

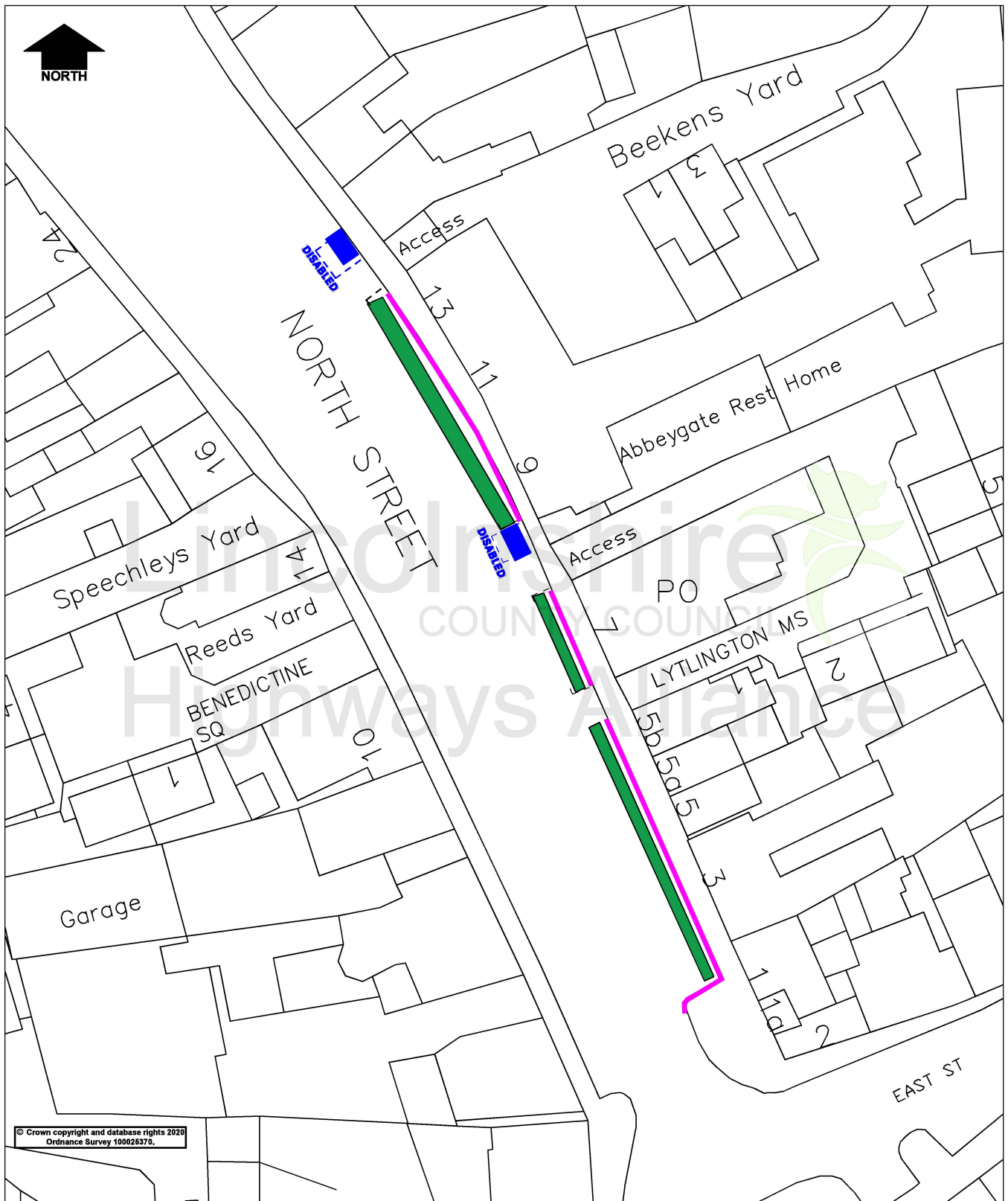
