

# ROAD TRAFFIC REGULATION ACT 1984

## LINCOLNSHIRE COUNTY COUNCIL

### (LINCOLN – SINCIL STREET)

#### (PROHIBITION OF DRIVING) ORDER 2025

THE LINCOLNSHIRE COUNTY COUNCIL in exercise of their powers under Sections 1(1), 2(1) and (2) and 3(2) of the Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. This Order shall come into operation on 20 and may be cited as the Lincolnshire County Council (Lincoln – Sincil Street) (Prohibition of Driving) Order 2025
2. Save as provided in Article 3 no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to enter or proceed on any road or length of road between the hours of 10am and 4pm as specified in the Schedule to this Order.
3. Nothing in Article 2 shall render it unlawful for a person to cause or permit any motor vehicle to enter or proceed on any road or length of road specified in the Schedule, if the vehicle is:-
  - (a) being used for or in connection with the conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to that length of road or where access cannot be obtained to premises on adjoining roads by any other public highway;
  - (b) being used to proceed to or from any premises on or adjacent to that length when on the occasion, is to be, or has been garaged, serviced, or repaired;
  - (c) in connection with the carrying out on, or on premises situated on or adjacent to, that length of road of any of the following operations, namely:
    - (i) building, industrial or demolition operations;
    - (ii) the removal of any obstruction to traffic;

- (iii) the maintenance, improvement or reconstruction of that length of road;
- (iv) the laying, erection, alteration or repair in or in land adjacent to that length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in the Digital Economy Act 2017;

(d) for Police, Fire Brigade or Ambulance purposes;

(e) in the service of a local authority, water undertaker or sewage undertaker in connection with work being carried out on, or on land adjacent to that length of road in pursuance of statutory powers or duties.

(f) a vehicle granted special written exemption by Lincolnshire County Council.

(g) being used for the provision of a local service as defined in section 2 of the Transport Act 2000.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

6. Any existing restriction or requirement made or having effect as if made under the Act of 1984 is hereby revoked insofar as it relates to the lengths and sides of the roads specified in this Order.

The LINCOLNSHIRE COUNTY COUNCIL in exercise of their powers under Sections Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as “the Act of 1984”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the said Act of 1984, hereby make the following Order:-

1. This Order shall come into operation on and may be cited as the Lincolnshire County Council (Lincoln – Various Roads) (One-Way Traffic) & (Revocation of One-Way Traffic) Order 2025
2. The Order cited as the Lincolnshire County Council (Lincoln City – Various Roads) (One Way Traffic) Consolidation Order 2013 shall have the following items revoked from Schedule 1 of said Order:

<u>Column 1 - Road Name</u>	<u>Column 2 - Direction of Travel</u>
Bus Station Western Service Road	North to South
Bus Station Northern Station Road	East to West
Central Station Western Access Road (From its junction with St Mary's Street in a southerly direction for a distance of 5 metres)	South to North
St Mary's Street/Pelham Bridge Slip Road (From its junction with Pelham Bridge in a westerly direction for a distance of 196 metres)	East to West
St Mary's Street/Norman Street (From a point 24 metres west of Sincil Street in an easterly direction to its junction with Broadgate)	West to East
St Mary's Street/Norman Street Island	Clockwise

3. No person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Civil Parking enforcement Officer cause or permit any vehicle to proceed in the length of road specified in column 1 of the Schedule to this Order in a direction other than that specified in Column 2 of that Schedule.

**STATEMENT OF REASONS**

- Lincolnshire County Council has been asked to investigate the section of Sincil Street, Lincoln outside the Bus Station which is being used by vehicles as a drop off/pick up point.
- Due to recent development in the area, the access off this section has been closed off therefore there is no requirement for traffic to enter this area which is currently putting pedestrians at risk.
- The proposal will be to prohibit all vehicles 10am-4pm, extend the existing one-way on Sincil Street southbound to St Mary's Street and introduce No Waiting at Any Time and No Loading 10am-4pm.
- Therefore, it is proposed to prohibit all vehicles 10am-4pm, extend the existing one-way order and prohibit waiting and loading as set out on the plans to the Order.
- The Chief Constable and City of Lincoln Council have been consulted, along with other local groups/companies.

THE LINCOLNSHIRE COUNTY COUNCIL in exercise of its powers under Sections 1, 2(1) and (2), 3, 4, 5, 32, 35, 45, 46, 49, 53, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and the Traffic Management Act 2004 (the Act of 2004) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This Order shall come into operation on 20 and may be cited as the Lincolnshire County Council (Lincoln – Sincil Street) (Prohibition of Waiting) Amendment Order 2025
2. The Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 Plans including the key (the 'Plans') are incorporated into this Order.
3. Plan ? of the Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 shall be amended.
4. Any restriction or requirement made or having effect as if made under the Act of 1984 or any other enactment is hereby revoked insofar as it relates to the length and sides of road specified in this Order.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

## **LINCOLNSHIRE COUNTY COUNCIL (LINCOLN – SINCIL STREET) (ONE WAY, PROHIBITION OF DRIVING & PROHIBITION OF WAITING & LOADING) ORDER 2025**

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to prohibit all vehicles 10am-4pm, extend the existing One Way system, introduce No Loading 10am-4pm and No Waiting at Any Time on Sincil Street up to St Mary's Street, Lincoln.


Some exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
