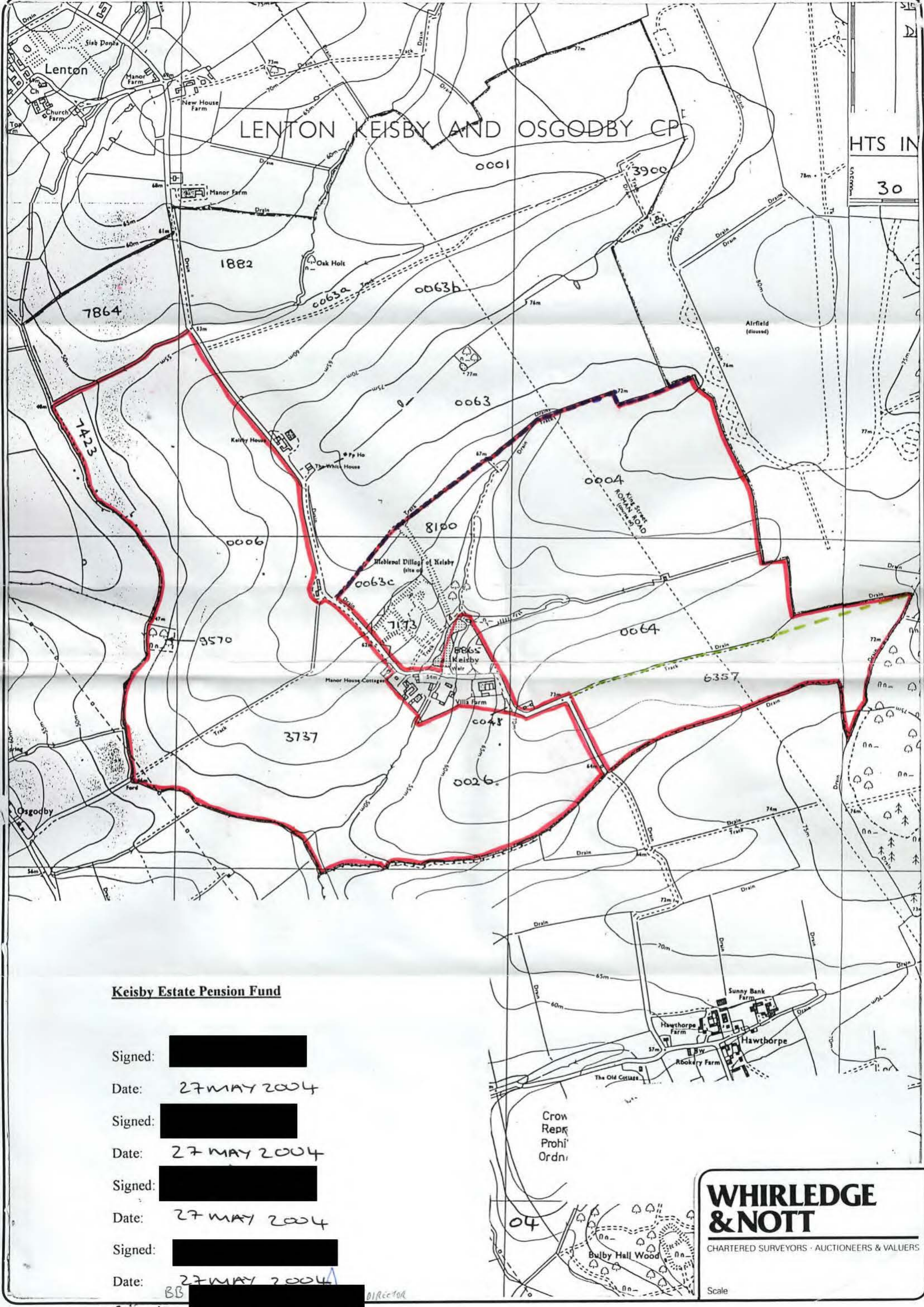

STATUTORY DECLARATIONSECTION 31 (6) OF THE HIGHWAYS ACT 1980

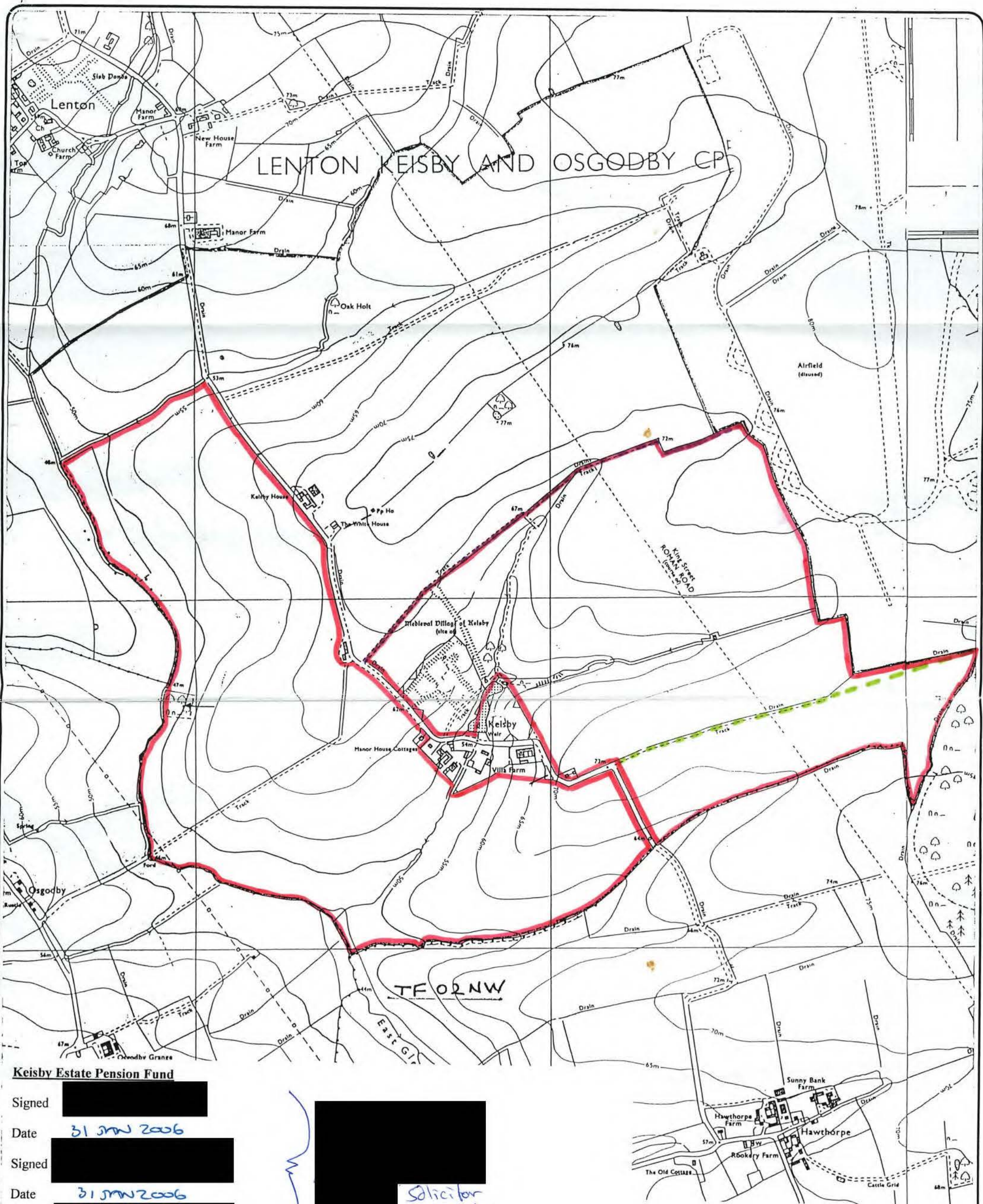
