

ROAD TRAFFIC REGULATION ACT 1984

LINCOLNSHIRE COUNTY COUNCIL

(BOSTON – SYDNEY STREET)

(PROHIBITION OF WAITING) REVOCATION ORDER 20

THE LINCOLNSHIRE COUNTY COUNCIL in exercise of its powers under Sections 1, 2(1) and (2), 3, 4, 5, 32, 35, 45, 46, 49, 53,124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and the Traffic Management Act 2004 (the Act of 2004) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This Order shall come into operation on _____ 20__ and may be cited as the Lincolnshire County Council (Boston – Sydney Street) (Prohibition of Waiting) Revocation Order 20__
2. The Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 Plans including the key (the 'Plans') are incorporated into this Order.
3. Plan ? of the Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 shall be amended.
4. Any restriction or requirement made or having effect as if made under the Act of 1984 or any other enactment is hereby revoked insofar as it relates to the length and sides of road specified in this Order.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

STATEMENT OF REASONS

- Lincolnshire County Council recently received a request to review the waiting restrictions at the above location.
- Investigations have shown that the introduction of a one-way system some years ago has rendered the existing No Waiting at Any Time restrictions that were in place to provide passing places, redundant.
- The removal of these restrictions will free up on-street parking in an area where parking is at a premium.
- Therefore, it is proposed to remove the existing waiting restrictions as set out on the plans to the Order.
- The Chief Constable and Boston Borough Council have been consulted, along with other local groups/companies.

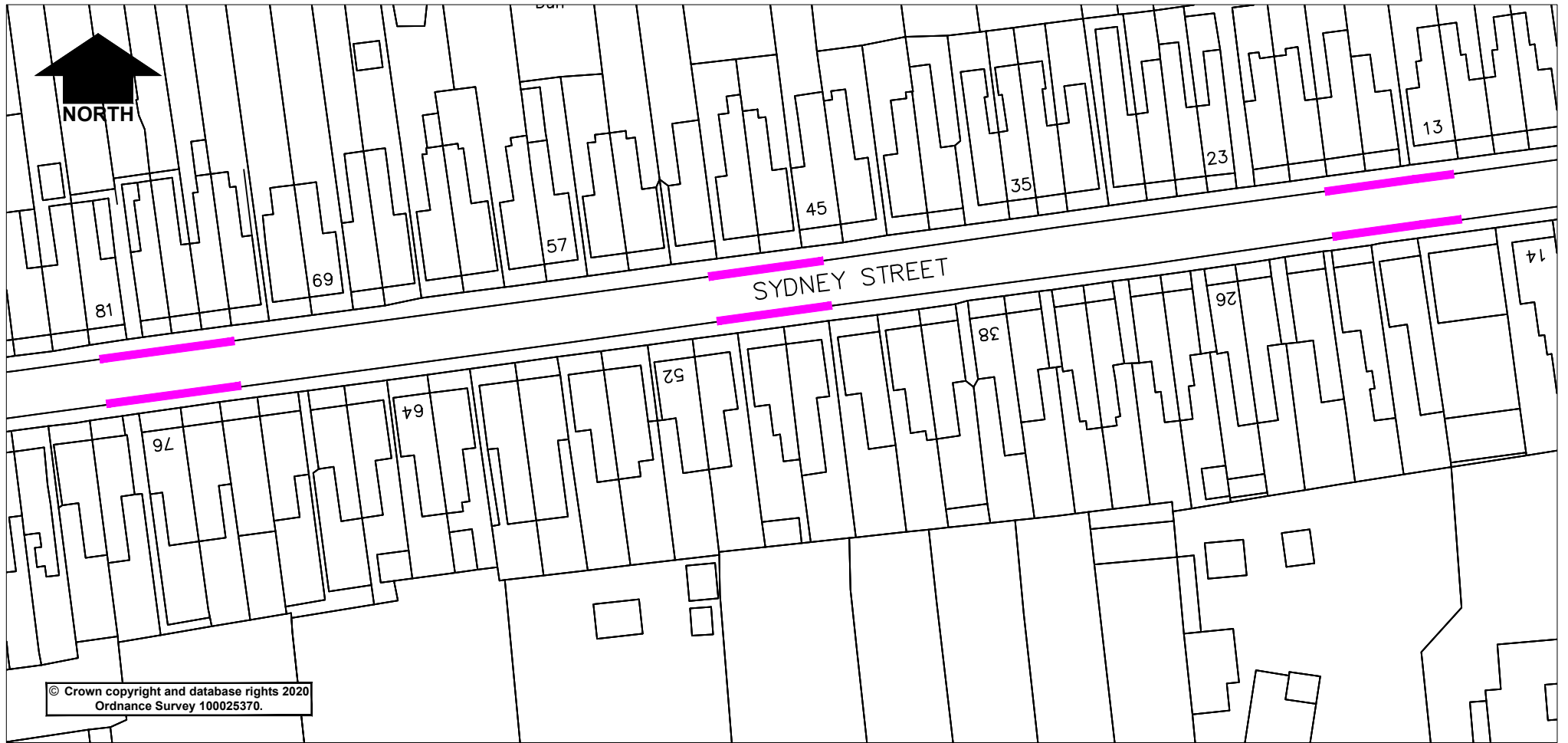
