

ROAD TRAFFIC REGULATION ACT 1984

LINCOLNSHIRE COUNTY COUNCIL

(REEPHAM – VARIOUS ROADS)

(PROHIBITION OF WAITING) AMENDMENT ORDER 2026

THE LINCOLNSHIRE COUNTY COUNCIL in exercise of its powers under Sections 1, 2(1) and (2), 3, 4, 5, 32, 35, 45, 46, 49, 53, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and the Traffic Management Act 2004 (the Act of 2004) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This Order shall come into operation on 20 and may be cited as the Lincolnshire County Council (Reepham – Various Roads) (Prohibition of Waiting) Amendment Order 20
2. The Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 Plans including the key (the 'Plans') are incorporated into this Order.
3. Plan ? of the Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 shall be amended.
4. Any restriction or requirement made or having effect as if made under the Act of 1984 or any other enactment is hereby revoked insofar as it relates to the length and sides of road specified in this Order.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

STATEMENT OF REASONS

- Investigations have shown that inconsiderate, and dangerous parking is occurring in the vicinity of Reepham Church of England Primary School, causing visibility and safety concerns for all road users.
- Therefore, it is proposed to prohibit waiting as set out on the plans to the Order.
- The Chief Constable, Reepham Parish Council and West Lindsey District Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to propose:

- No Waiting at any time around the junctions of Mellows Close, Dawsons Lane and Chapel Close
- No Waiting Mon - Fri 8:30am - 9:30am and 3:00pm - 4:00pm between the junctions of Mellows Close and Dawsons Lane
- Mandatory School Keep Clear markings outside the entrance of Reepham Church of England Primary School which will be operative Mon - Fri 8:30am - 9:30am and 3:00pm - 4:00pm
- A Bus stop clearway opposite 4 High Street where the existing bus shelter is. The clearway will ensure unrestricted access for scheduled bus services by prohibiting the stopping, waiting and loading of any vehicle except a bus. The clearways will be in operation between the hours of 7am to 8pm Monday to Saturday.


Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
