

**ROAD TRAFFIC REGULATION ACT 1984**  
**LINCOLNSHIRE COUNTY COUNCIL**  
**(LINCOLN, WESTERN AVENUE & BOULTHAM PARK ROAD)**  
**(PROHIBITION OF WAITING) AMENDMENT ORDER 20**

THE LINCOLNSHIRE COUNTY COUNCIL in exercise of its powers under Sections 1, 2(1) and (2), 3, 4, 5, 32, 35, 45, 46, 49, 53,124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and the Traffic Management Act 2004 (the Act of 2004) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This Order shall come into operation on \_\_\_\_\_ 20\_\_ and may be cited as the Lincolnshire County Council (Lincoln, Western Avenue & Boultham Park Road) (Prohibition of Waiting) Amendment Order 20
2. The Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 Plans including the key (the 'Plans') are incorporated into this Order.
3. Plan ? of the Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 shall be amended.
4. Any restriction or requirement made or having effect as if made under the Act of 1984 or any other enactment is hereby revoked insofar as it relates to the length and sides of road specified in this Order.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

# **PUBLIC NOTICE**

## **LINCOLNSHIRE COUNTY COUNCIL (LINCOLN, WESTERN AVENUE & BOULTHAM PARK ROAD) (PROHIBITION OF WAITING) AMENDMENT ORDER 20 (BUS STOP CLEARWAY)**

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at the following locations:

- Introduce 'No Waiting at Any Time' restrictions at both junctions of Western Avenue with Boultham Park Road, on the eastern side, extending to the rear of number 231 and the access of number 67.
- Introduce 'No Waiting between Mon- Fri 8:00am – 9:30am to 2:30pm – 4:00pm' restrictions on both sides of the carriageway on Western Avenue, from the junction with Boultham Park Road to number 71a and the rear boundary of 216.
- Introduce 'No Stopping Mon – Fri 8am – 4:30pm on entrance markings' on the Western side of the carriageway on Western Avenue in the vicinity of number 71a to 73.

Also introducing Bus Stop Clearway, fronting 216 Boultham Park Road, as defined in the Traffic Signs Regulations and General Directions 2016. The Bus Stop Clearway will be in operation 24 hours daily and will ensure unrestricted access for scheduled bus services by prohibiting the stopping, waiting and loading of any vehicle except a bus.

Exemptions are included on the no waiting at any time which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.

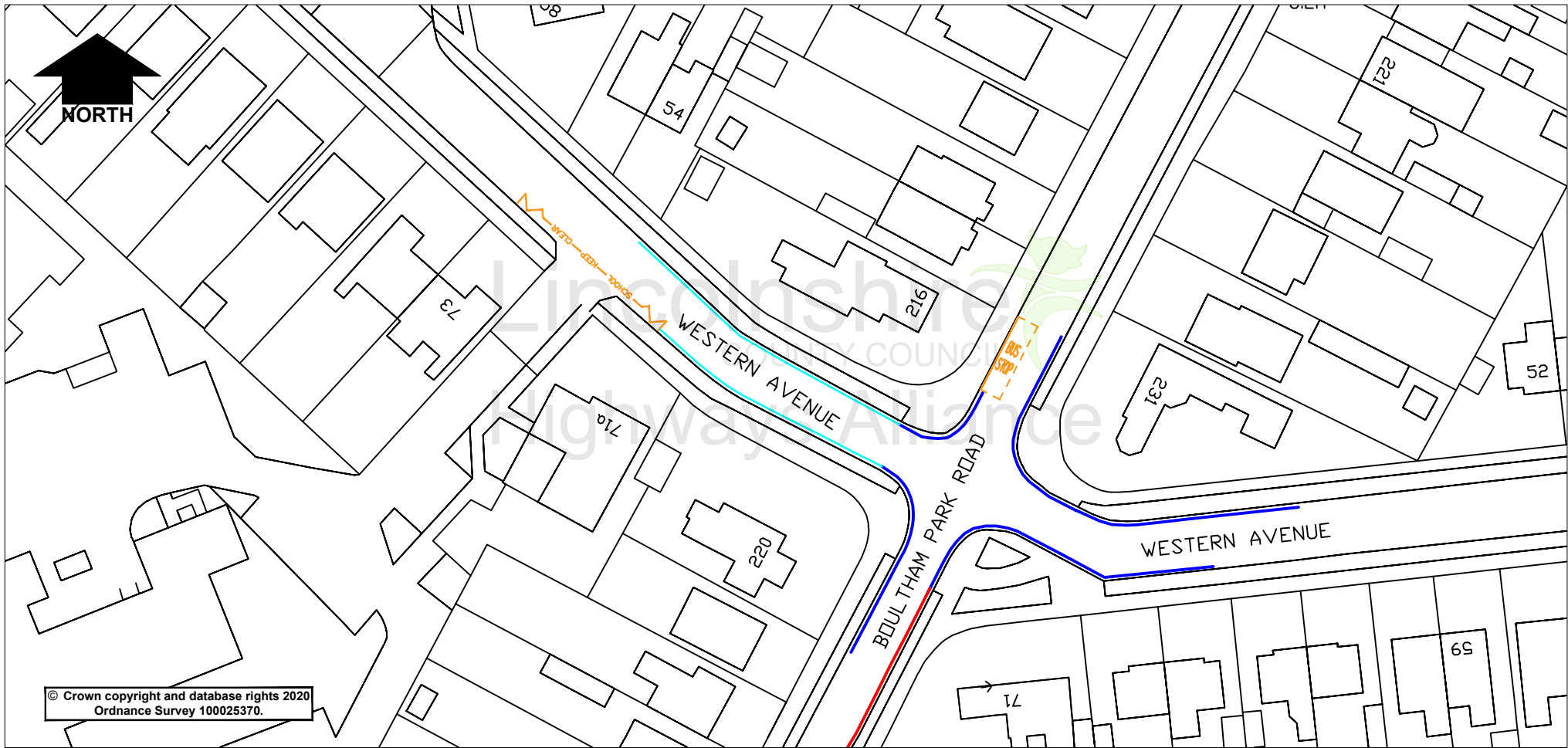

**STATEMENT OF REASONS**

- Following investigations at the above-mentioned location it was found that during peak school drop off/pick up times there are vehicles parked/waiting on the advisory 'School Keep Clear' markings.
- The introduction of a formal Traffic Regulation Order will discourage parking/waiting on the 'School Keep Clear' markings and enable civil parking enforcement officers to issue Penalty Charge Notices where appropriate.
- Additional investigations found that there is an increased need for further restrictions to improve visibility in the surrounding area and on the junctions, the proposals will remove any parked vehicles.
- The proposals will facilitate traffic flow, ensure all accesses are kept clear and improve visibility and road safety for all users.
- Establishing the Bus Stop Clearway at the above location will ensure unrestricted access for scheduled bus services by prohibiting the stopping, waiting and loading of any vehicle except a bus. The clearway will be in operation 24 hours daily.
- Waiting restrictions in the surrounding area will support the unrestricted access for buses passing and prevent inconsiderate parking on the nearby junctions.
- Therefore, it is proposed to prohibit waiting as set out on the plans to the Order.
- The Chief Constable and Lincoln City Council have been consulted, along with other local groups/companies.
