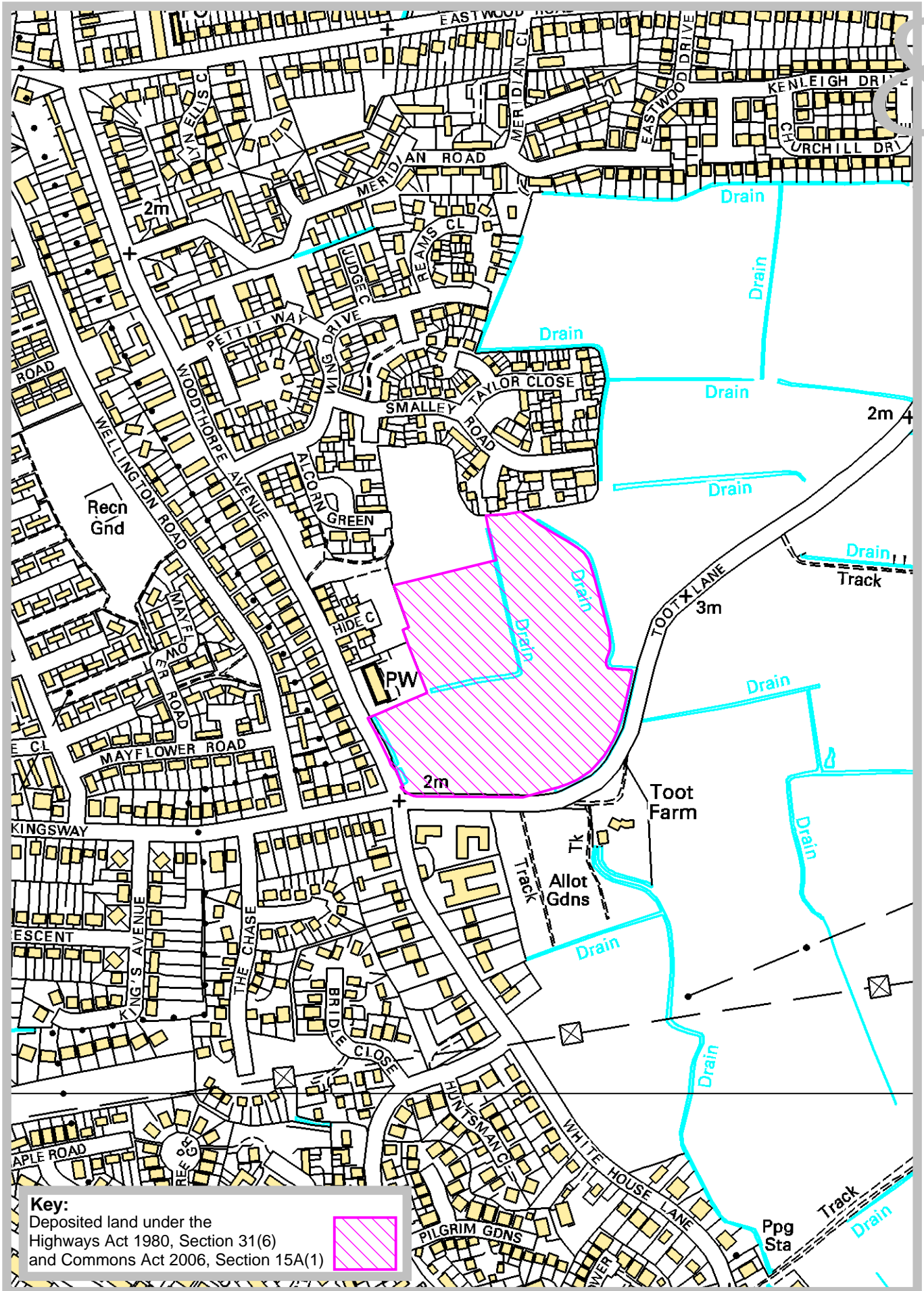

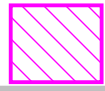
REGISTER OF DEPOSITS
