

- 1. Statutory Declaration dated 28 March 1995 in particular I would refer you to points 3 and 4 which states that Spout Yard is a through road which has served properties for over 100 years
- 2. Local Authority Search dated 26 July 1996 in the section 3.1 Enquiries of the Local Authority, 'are roadways maintainable at the public expense' it is stated yes 'coloured blue' you will note that the road either side of Spout Yard are maintainable at the public expense. In the case of Folkstone Corp v Brockman [1914] AC 338 it was stated 'one obvious area for evidence is the nature of the way over which the public right of way is claimed. If the way lead from one recognised way to another or from one inhabited settlement to another, the inference may be relatively easy to draw.'
- 3. Conveyance dated 13 June 1970 please see attached map this highlights the fact that Spout Yard remains largely unchanged. Please also note that the just beyond Spout Yard was East Lindsey District Council property.
- 4. .Tax Map 1906 tax map (96-TAX MAP/48/13) and accompanying records showing that Spout Yard was not privately owned. (Please note that all other 'white roads' are in fact now owned by the local authority. You will also note that due to the age of the map, there has been some damage and therefore it has been stuck together again. Unfortunately, the map has been put back together disjointed and on closer inspection you will note that Spout Yard is in fact a through road, (Spout Yard has been coloured blue for your assistance.)
- 5. Archived photograph (1960's) showing a vehicle on Spout Yard and a garage.
- 6. A photograph of the street today you will note that the properties on the street are visibly old in character old and the property seen in Document 6 is still in existence.
- 7. Extract of the William Brown Sketch 1846 whilst it is appreciated that this is a drawing rather than a photograph, it is widely recognised as an accurate panorama of Louth, at that time. The extract taken shows Spout Yard (please see the dashed blue mark) you will please note that it is a through road, past the School and across the river. Please also note the presence of a horse and cart down this road.
- 8. A map depicting Louth flood 29 May 1920 you will again note the existence of Spout Yard coloured blue.
- 9. A Map dated 1805 Spout Yard is coloured blue.
