

PUBLIC NOTICE

LINCOLNSHIRE COUNTY COUNCIL (LINCOLN – SHAKESPEARE STREET) (PROHIBITION OF WAITING) AMENDMENT ORDER 2020

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to install new No Waiting at Any Time restrictions on Shakespeare Street, Lincoln near the junction with High Street.

Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.

STATEMENT OF REASONS
