Proposal to stop up part of the public highway at Edinburgh Road, Brookenby, Market Rasen, Lincolnshire

NOTICE is hereby given that in accordance with section 116 of the Highways Act 1980 an application will be made to the Justices of the Peace of the Local Justice Area of Lincolnshire on Monday 6 April 2020 at 10.00am at the Lincoln Magistrates' Court, The Court House, 358 High Street, Lincoln, LN5 7QA for stopping up part of the public highway comprising approximately 53.35 square metres of land adjoining 1 Edinburgh Road, Brookenby, Market Rasen. The areas of land to be stopped up are a pathway between points A-B on the Stopping Up Plan and coloured blue thereon and a pathway between points C-D shown coloured red on the Stopping Up Plan.

The Plan can be inspected at all reasonable times at the offices of Lincolnshire County Council, County Offices, Newland, Lincoln LN1 1YS (Main Reception) and West Lindsey District Council, Guildhall, Marshall's Yard, Gainsborough, Lincolnshire DN21 2NA.

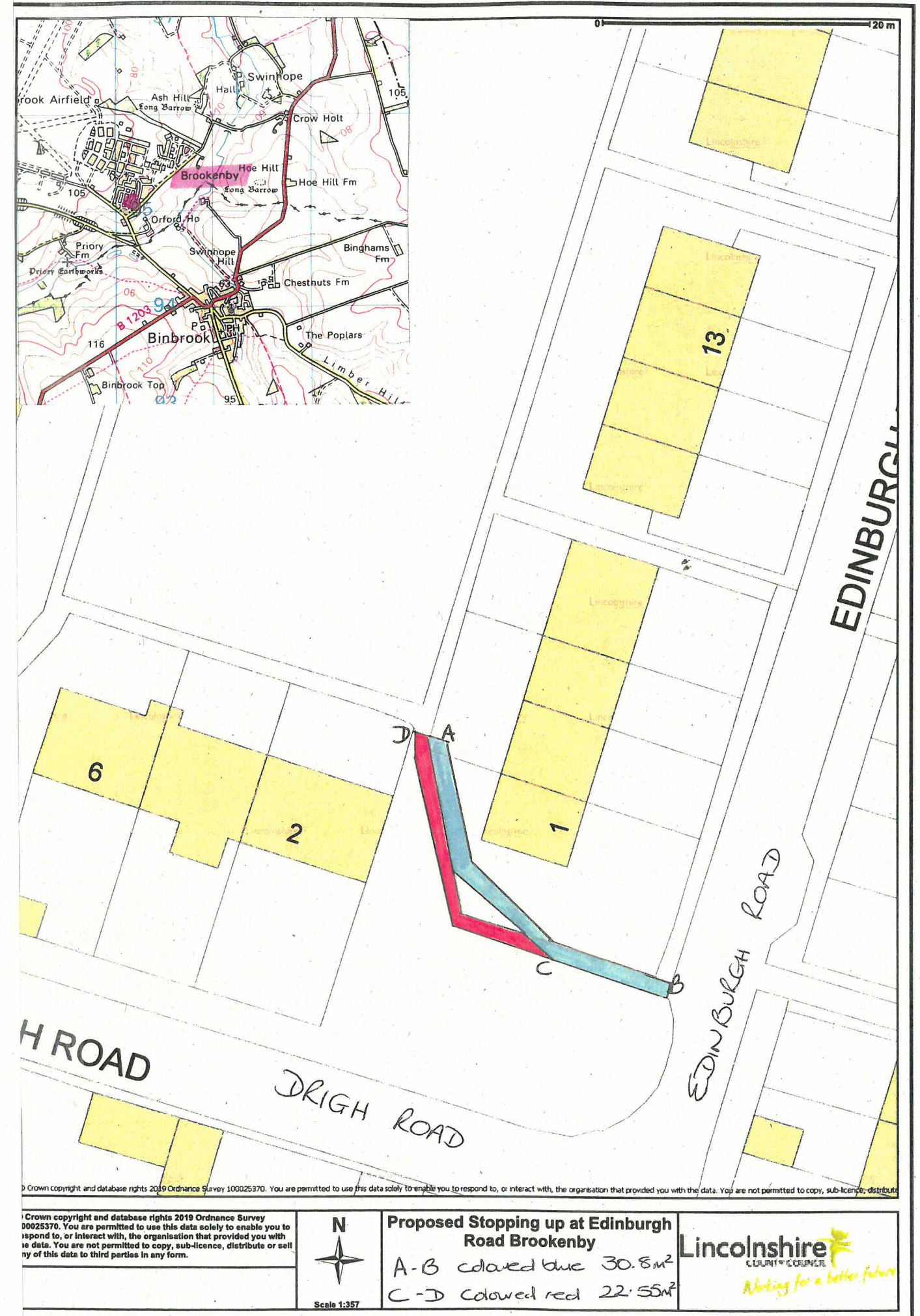
The Order sought is for stopping up the said areas of land for the purposes of all traffic on the grounds that they are unnecessary.
