NOTICE is hereby given that in accordance with section 116 of the Highways Act 1980 an application will be made to the Justices of the Peace of the Local Justice Area of Lincolnshire on Monday 6 April 2020 at 10.00am at the Lincoln Magistrates' Court, The Court House, 358 High Street, Lincoln, LN5 7QA for stopping up part of the public highway comprising approximately 2220 square metres of land forming Green Lane, off Stragglethorpe Lane, Stragglethorpe in the parish of Brant Broughton and Stragglethorpe. The area of land to be stopped up is shown on the Stopping Up Plan and coloured red thereon.

The Plan can be inspected at all reasonable times at the offices of Lincolnshire County Council, County Offices, Newland, Lincoln LN1 1YS (Main Reception) and North Kesteven District Council, Council Offices, Kesteven Street, Sleaford, Lincolnshire NG34 7EF.

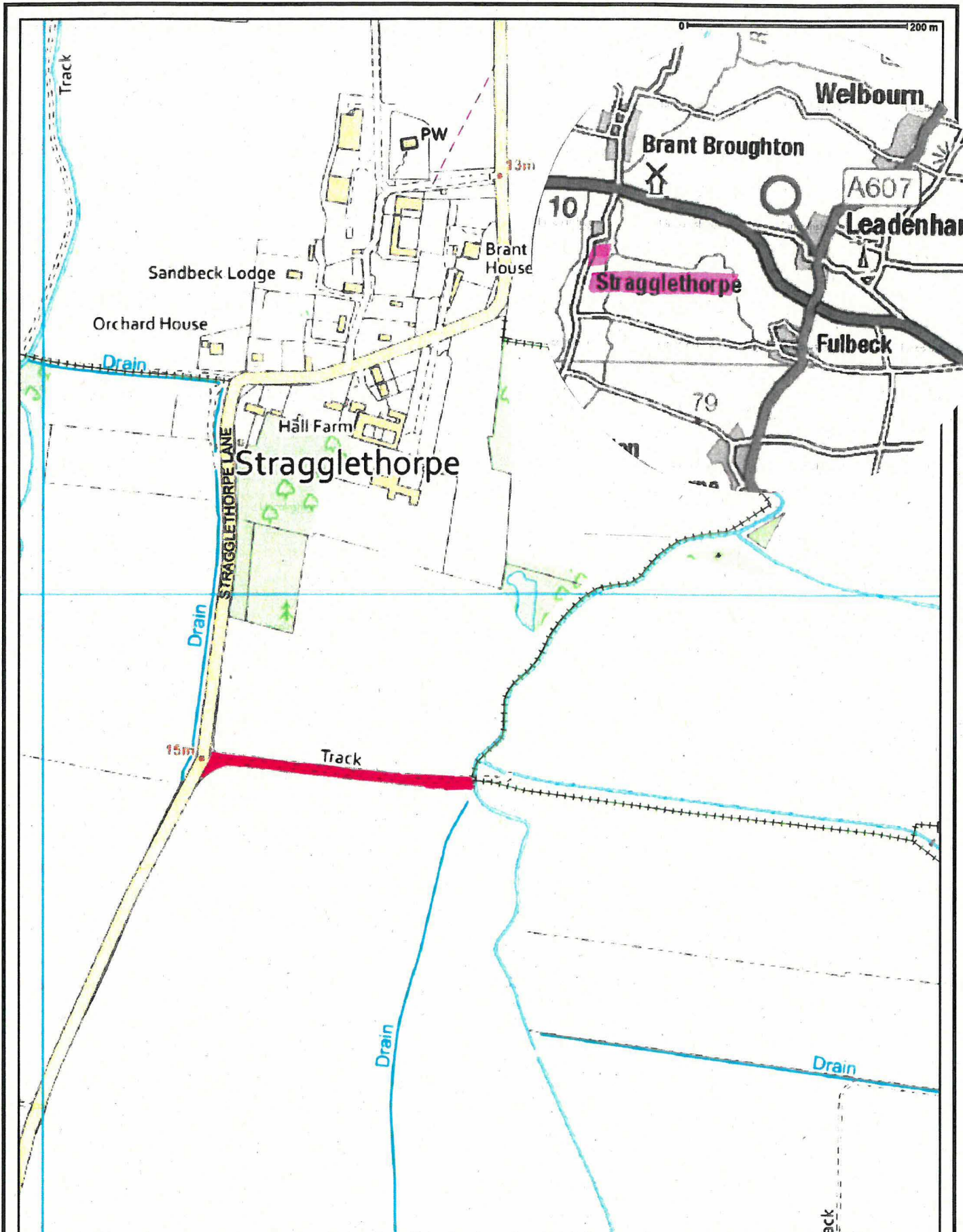
