

**LINCOLNSHIRE COUNTY COUNCIL
(WYBERTON – PILGRIM WAY)
(40MPH SPEED LIMIT) ORDER 20
SHARED CYCLETRACK/FOOTWAY**

STATEMENT OF REASONS

- The proposed speed limit is to improve road safety in the area following new housing developments in the vicinity.
- When comparing the conditions to the current speed limit policy, a 40mph speed limit is recommended.
- To promote sustainable travel a shared cycletrack/footway will also be installed on Pilgrim Way with some minor modifications on London Road to link the facilities.
- Therefore, in accordance with the County Council's Policy, it is proposed to introduce a speed limit as per the schedules in the Order.
- The Chief Constable and Boston Borough Council have been consulted, along with other local groups/companies.

LINCOLNSHIRE COUNTY COUNCIL (WYBERTON – PILGRIM WAY) (40MPH SPEED LIMIT) ORDER 20 NOTICE OF INTENTION TO ESTABLISH A SHARED CYCLETRACK/FOOTWAY

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to restrict the speed of vehicles to 40mph on Pilgrim Way, Wyberton.

It is also proposed to establish Pilgrim Way as a shared cycle/pedestrian way under Sections 65(1) and 66(4) of the Highways Act 1988. The Cycletracks Act 1984 will apply to this length should the proposal be confirmed and will be distinguished by special signs and markings. In order to link the cycletrack/footway some minor modifications will be made to the existing cycle/footway facilities on London Road.

The LINCOLNSHIRE COUNTY COUNCIL in exercise of their powers under Sections 84 (1) and (2) of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order may be cited as the Lincolnshire County Council () (40mph Speed Limit) Order 20 and shall come into operation on.
2. No person shall drive any motor vehicle at a speed exceeding 40mph on the length of road specified in the Schedule to this Order.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3 (5) of those regulations.

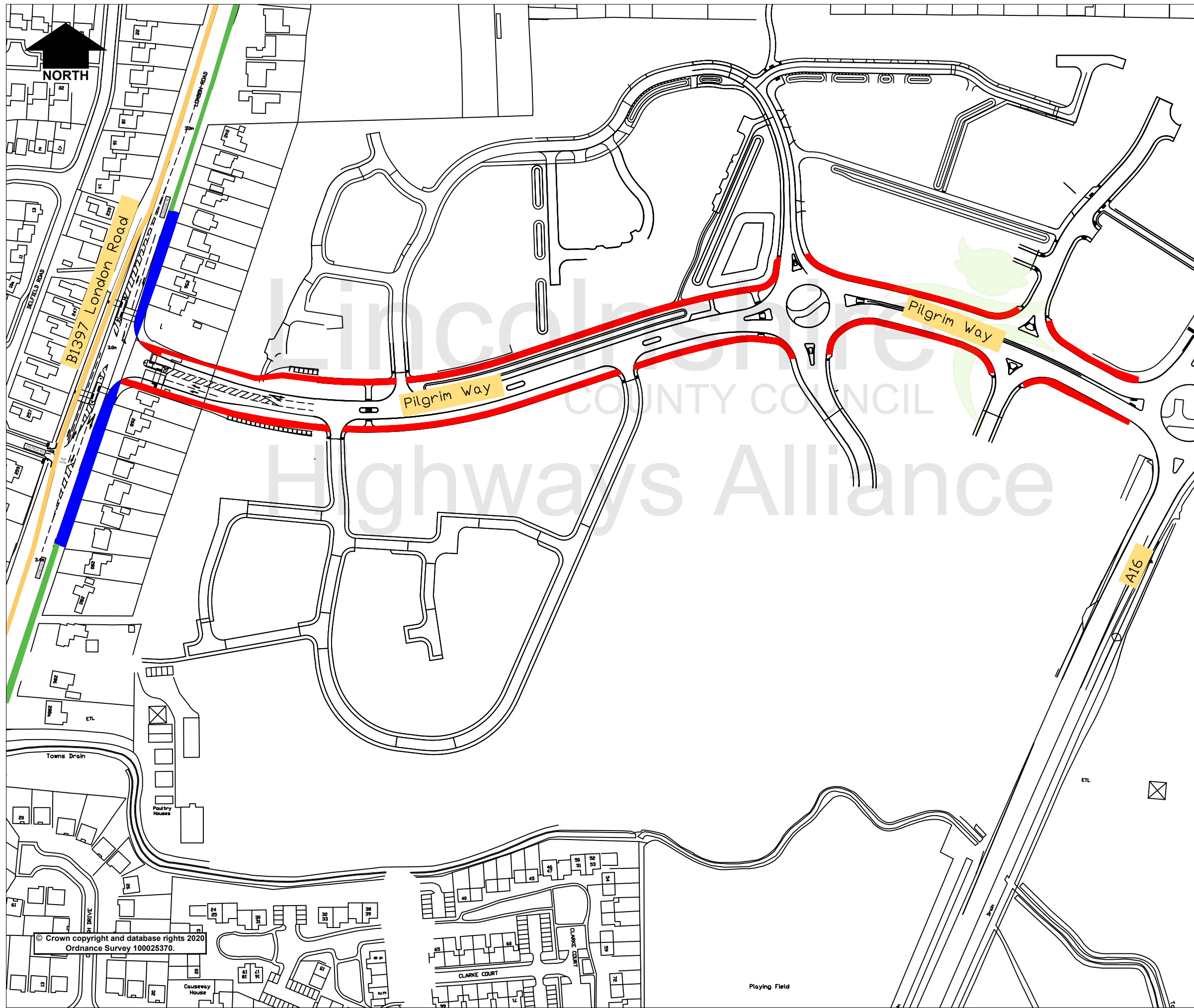

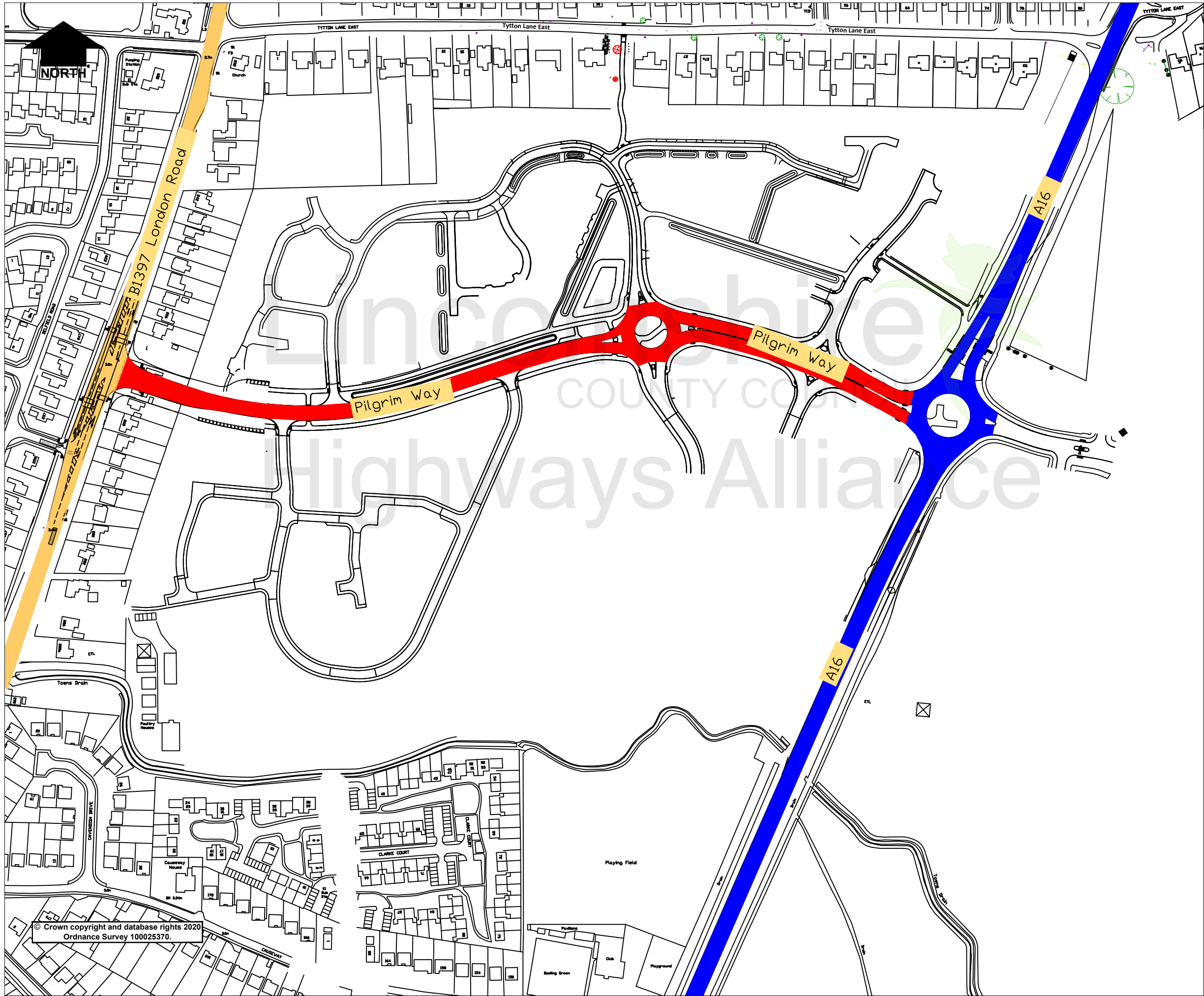
