

PUBLIC NOTICE

LINCOLNSHIRE COUNTY COUNCIL (SPALDING - WINSOVER ROAD) (PROHIBITION OF WAITING) AMENDMENT ORDER 20

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to introduce No Waiting At Any Time restrictions in the vicinity of A151 Winsover Road when it meets with the junction of Carrington Road in Spalding to make it safer for all road users.

Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.

STATEMENT OF REASONS

- Requests have been made to review the waiting restrictions in the area, some being highlighted with the introduction of Civil Parking Enforcement.
- It is proposed to introduce No Waiting At Any Time restrictions in the vicinity of A151 Winsover Road when it meets with the junction of Carrington Road in Spalding to make it safer for all road users.
- We are also proposing to include extra lengths of waiting restrictions on Winsover Road either side of the existing pedestrian crossing to help remedy this issue.
- Therefore, in accordance with the County Council's Policy, it is proposed to prohibit waiting as set out on the Plans to the Order.
- The Chief Constable and South Holland District Council have been consulted, along with other local groups/companies.
