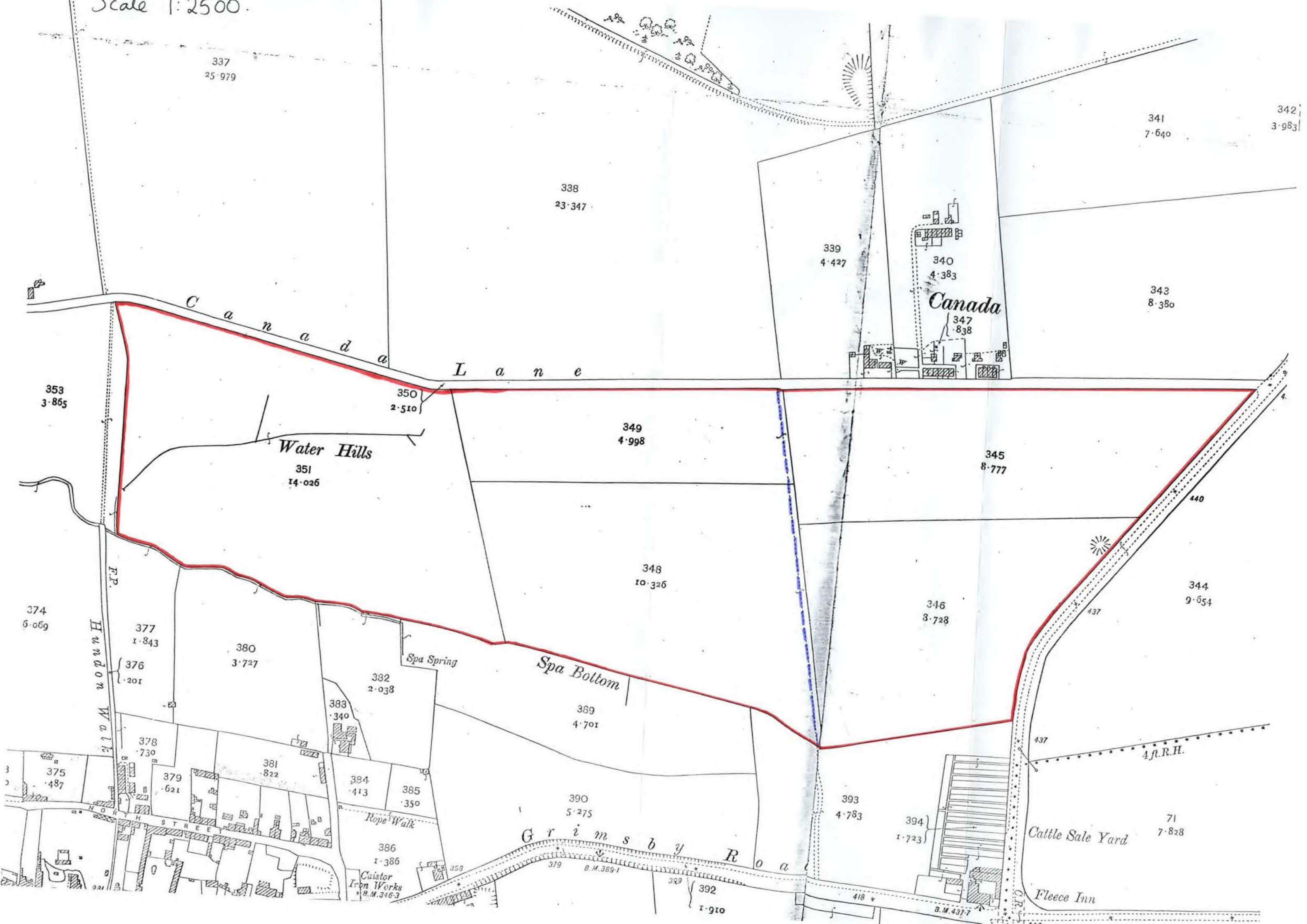
1. I am the owner of the freehold property at Caistor shown edged red on the map (**the Map**) attached to this statement (**the Property**).
2. The Property comprises field numbers 345, 346, 348, 349 and 351 shown on the Map. I have owned the land comprised in field number 346 since 5 June 1984, the land comprised in field number 345 since 6 October 1980, the land comprised in field numbers 348, 349 and 351 since 3 January 1978.
3. The Property is situated in the local authority district of West Lindsey in the county of Lincolnshire.
4. The way hatched purple on the Map is a public footpath.
5. There are no other ways over the Property which have been dedicated as highway.

STATUTORY DECLARATION TO SUPPORT A STATEMENT AND PLAN LODGED

I, ROGER MARK BAYLES STRAWSON, of Lings Farm House, Croxby Top, Market Rasen, Lincolnshire LN7 6BN do solemnly and sincerely declare that:

1. I am the owner of the freehold property at Caistor (**the Property**) shown edged red on the Map referred to in paragraph 3 of this declaration.
2. I have owned the land comprised in field number 346 shown on the Map since 5 June 1984, the land comprised in field number 345 shown on the Map since 6 October 1980 and the land comprised in field numbers 348, 349 and 351 shown on the Map since 3 January 1978.
3. On the *18<sup>th</sup> September* 2013, I deposited with Lincolnshire County Council a statement (**Statement**) and map (Map) pursuant to section 31(6) of the Highways Act 1980 in respect of the Property. The Statement acknowledged that:
  - 3.1 The way hatched purple on the Map is a public footpath.
4. The Statement stated that there are no other ways over the Property which have been dedicated as highway.
5. Since *18<sup>th</sup> September* 2013, which is the date the Statement was deposited with Lincolnshire County Council, there has been no dedication of any further highway over the Property.
6. I have no current intention to dedicate any further highway over the Property.
