STATEMENT OF REASONS

- Concerns have been expressed with regards to parking in the emergency vehicles only layby outside Tanglewood.
- Vehicles have regularly been observed parking in the layby and outside the school gates resulting in difficulties for all road users and raising safety concerns.
- The proposals will facilitate traffic flow, ensure all accesses are kept clear and improve visibility and road safety for all users.
- Therefore, in accordance with the County Council's Policy, it is proposed to prohibit waiting as set out on the plans to the Order.
- The Chief Constable, Coningsby Town Council and East Lindsey District Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting as set out in the Schedule below:

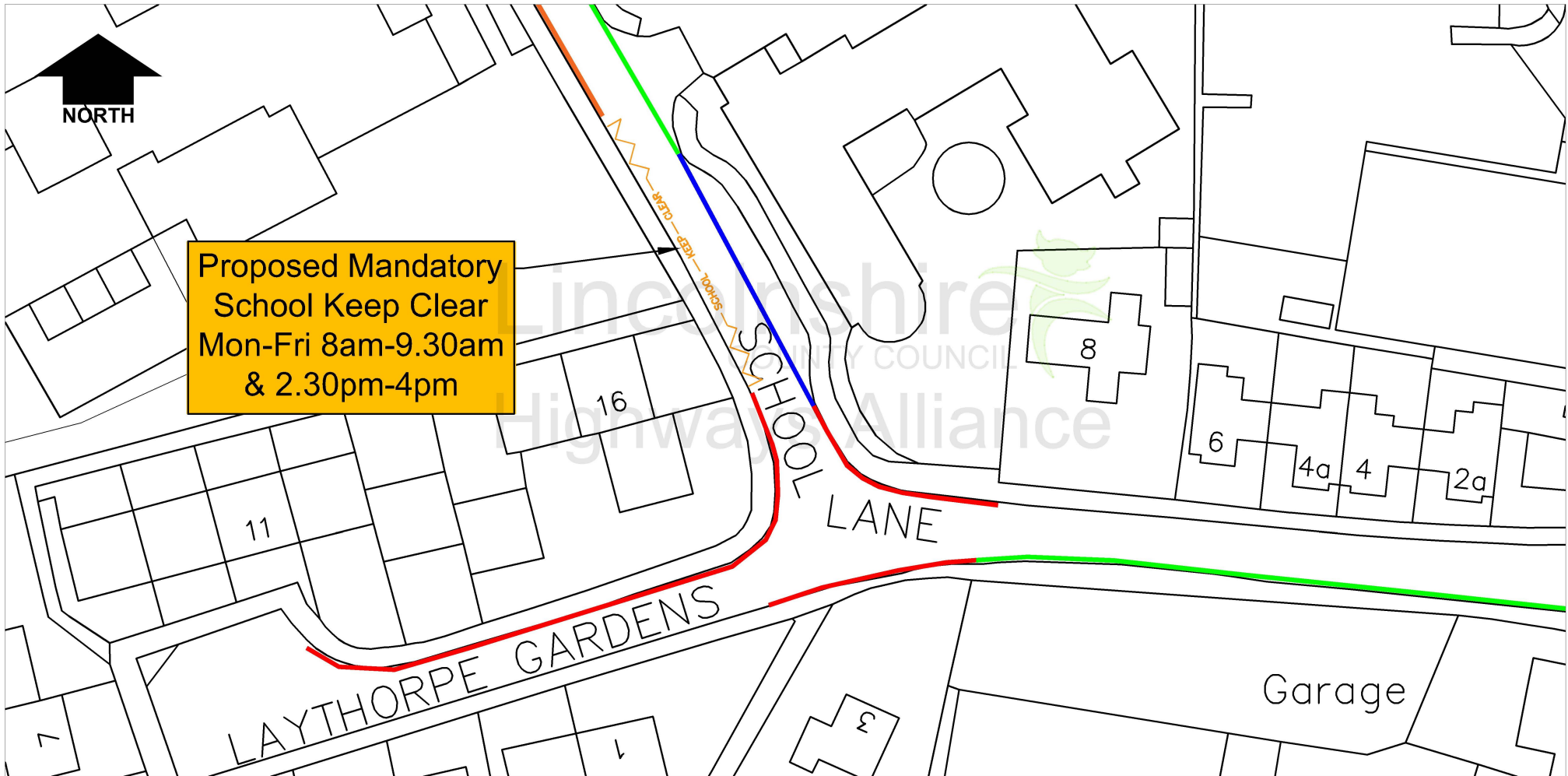
- Introduce Mandatory School Keep Clear Monday – Friday 8-9:30am and 2.30-4pm between the existing bus stand and no waiting at any time outside the school gates.
- Introduce No Waiting at Any Time in front of the layby outside Tanglewood.

Some exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
