 Plans including the key (the 'Plans') are incorporated into this Order.
- Plan TF136781 of the Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 shall be amended.
- 4. Any restriction or requirement made or having effect as if made under the Act of 1984 or any other enactment is hereby revoked insofar as it relates to the length and sides of road specified in this Order.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

STATEMENT OF REASONS

- Following investigations at the above mentioned location it was found that during peak school drop off/pick up times there are vehicles parked/waiting on the double yellow lines reducing the safety and effectiveness of the School Crossing Patrol.
- The introduction of a formal Traffic Regulation Order will discourage parking/waiting on the no loading markings and enable civil parking enforcement officers to issue Penalty Charge Notices where appropriate.
- The proposals will facilitate traffic flow, ensure all accesses are kept clear, improve the safety and visibility of the School Crossing Patrol as well as improving visibility and road safety for all users.
- Therefore, it is proposed to prohibit waiting and loading as set out on the Plans to the Order.
- The Chief Constable and City of Lincoln Council have been consulted, along with other local groups/companies.
