Having given due regard to the appropriate local and national planning policy guidance (in particular the National Planning Policy Framework), Lincolnshire County Council (as Highway Authority and Lead Local Flood Authority) has concluded that the proposed development would not be expected to have an unacceptable impact upon highway safety or a severe residual cumulative impact upon the local highway network or increase surface water flood risk and therefore does not wish to object to this planning application.

### **Introduction/Site Location**

Ermine Street Farm, High Dike, Byard's Leap, Cranwell, Lincolnshire, NG32 3RN is accessed via a private track and is surrounded by agriculture land.

The proposal is for the erection of 2 No. additional poultry houses with attached control room, feed bins and feed blending rooms.

The proposed poultry houses are identical to the existing poultry houses on the site and measure 110m x 20.42 with attached control rooms and catching canopies on the western elevation which measures 12.51m x 4m. The feed blending rooms extend to 4m x 3m. The proposal also includes 4 No. feed bins and an expanded concrete apron.

## **Existing Conditions**

On the farm there are 4 existing poultry houses concealed within the landscape by a bund, the soil bund is on the northern and eastern boundaries.

# Highway safety/Highway capacity

Access to the proposed development will be via the existing farm entrance to High Dyke. As the overall development is neutral in terms of bird numbers, the traffic generation impacts of the development will be neutral.

# Site Layout

The proposed poultry houses are identical to the existing poultry houses on the site and will be sited adjacent to the existing poultry houses on the northern side.

# Flood Risk and Drainage

As Lead Local Flood Authority, Lincolnshire County Council is required to provide a statutory planning consultation response with regard to Drainage on all Major Applications. This application Ermine Street Farm, High Dike, Byard's Leap, Cranwell, Lincolnshire, NG32 3RN All drainage will be on private land. Therefore, the Lead Local Flood Authority does not consider that this proposal would increase flood risk in the immediate vicinity of the site.
