

ROAD TRAFFIC REGULATION ACT 1984
LINCOLNSHIRE COUNTY COUNCIL
(GAINSBOROUGH – PARK SPRINGS ROAD, PILGRIMS APPROACH
& PILGRIMS WAY)
(PROHIBITION OF WAITING) AMENDMENT ORDER 2025

THE LINCOLNSHIRE COUNTY COUNCIL in exercise of its powers under Sections 1, 2(1) and (2), 3, 4, 5, 32, 35, 45, 46, 49, 53, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and the Traffic Management Act 2004 (the Act of 2004) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This Order shall come into operation on 1 January 2025 and may be cited as the Lincolnshire County Council (Gainsborough – Park Springs Road, Pilgrims Approach & Pilgrims Way) (Prohibition of Waiting) Amendment Order 2025
2. The Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 Plans including the key (the 'Plans') are incorporated into this Order.
3. Plan ? of the Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 shall be amended.
4. Any restriction or requirement made or having effect as if made under the Act of 1984 or any other enactment is hereby revoked insofar as it relates to the length and sides of road specified in this Order.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

STATEMENT OF REASONS

- Investigations have shown that inconsiderate parking is occurring, causing visibility and safety concerns for all road users on Pilgrims Approach. This is the only route into Brooklands for emergency service vehicles so unrestricted access is required at all times.
- Revocation of a small area of no waiting at any time restrictions on Park Springs Road which will allow further on street parking for residents.
- Therefore, it is proposed to prohibit waiting as set out on the plans to the Order.
- The Chief Constable, Gainsborough Town Council and West Lindsey District Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting as set out in the Schedule below.

- To extend the no waiting at any time restriction fronting numbers 2-14 (even numbers only) on Pilgrims Approach.
- To introduce no waiting at any time restrictions at the junction of Pilgrims Approach and Pilgrims Way.
- Revoke no waiting at any time restrictions fronting number 80 Park Springs Road.

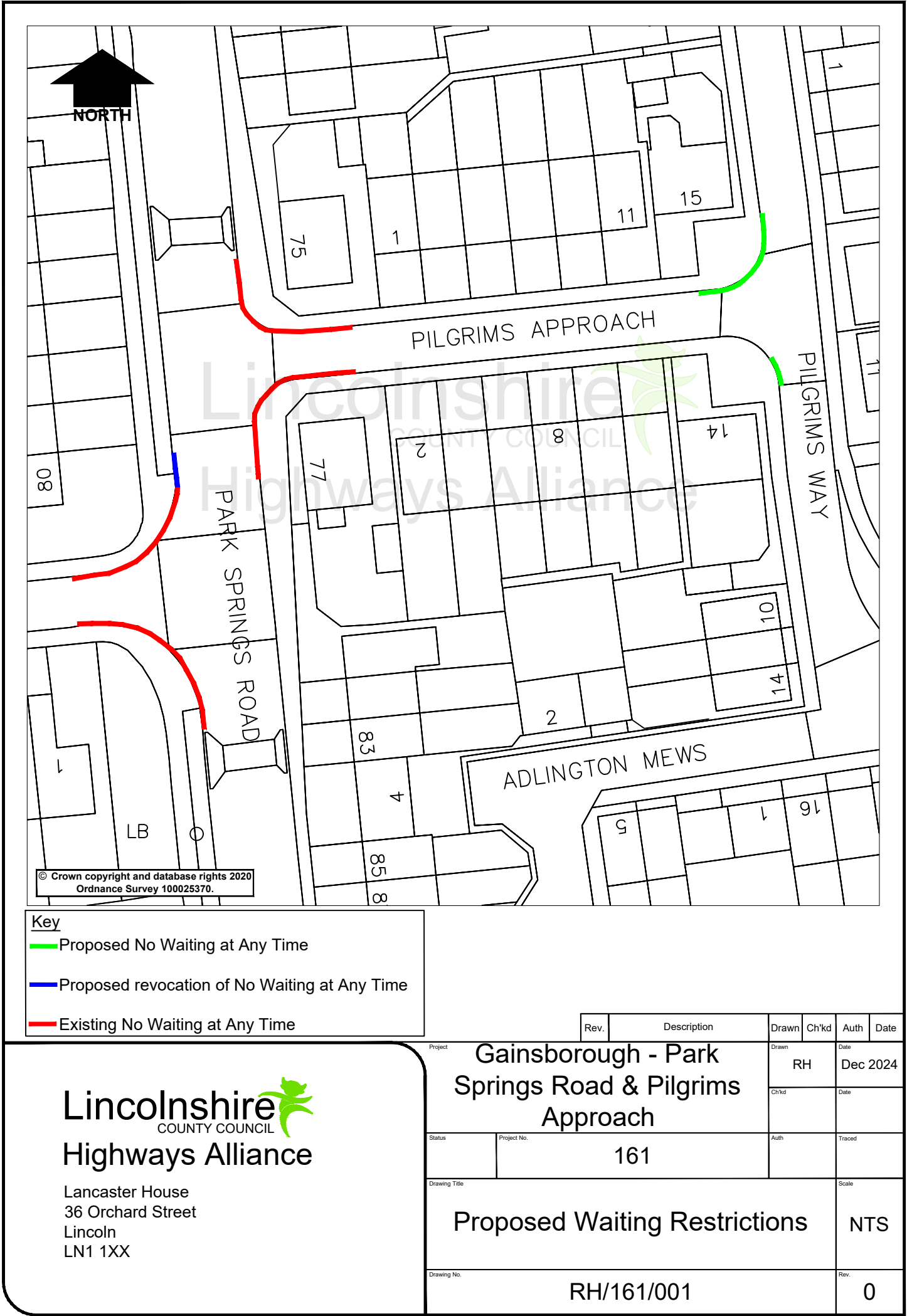
Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
