# **No Objections**

Having given due regard to the appropriate local and national planning policy guidance (in particular the National Planning Policy Framework), Lincolnshire County Council (as Highway Authority and Lead Local Flood Authority) has concluded that the proposed development would not be expected to have an unacceptable impact upon highway safety or a severe residual cumulative impact upon the local highway network or increase surface water flood risk and therefore does not wish to object to this planning application.

#### Introduction/Site Location

The proposal is change of use of land to equestrian use and erection of stable buildings and menage at Harts Close, Welbourn Road, Brant Broughton, Lincoln, Lincolnshire, LN5 OSP

## **Existing Conditions**

The site is occupied by a bungalow and associated access, garden and car parking area with outbuildings. The eastern area of the site where the stables are proposed is open meadowland. The site is bounded by overgrown and dense hedgerows and bushes.

#### Highway safety/Highway capacity

Access to the site is gained Welbourn Road by two separate private accesses. The western most access is used by the occupants of the dwelling with a gravel driveway from the access to an adequate parking area adjacent to the property. The proposal will remain strictly private and solely for family members therefore no increase in traffic volumes to the site.

#### Site Layout

The proposal site for the stables and manege is located on meadowland in the southwest of the site.

## Flood Risk and Drainage

As Lead Local Flood Authority, Lincolnshire County Council is required to provide a statutory planning consultation response with regard to Drainage on all Major Applications. This application change of use of land to equestrian use and erection of stable buildings and menage. Therefore the Lead Local Flood Authority does not consider that this proposal would increase flood risk in the immediate vicinity of the site.

In regard to surface water, new field drains will be installed and the manege will have its own drainage system, which will channel water into the field drains, which in turn drain to the field ditch.
