

ROAD TRAFFIC REGULATION ACT 1984
LINCOLNSHIRE COUNTY COUNCIL
(HECKINGTON – ST ANDREWS STREET AND CHURCH STREET)
(PROHIBITION OF WAITING) AMENDMENT ORDER 2025

THE LINCOLNSHIRE COUNTY COUNCIL in exercise of its powers under Sections 1, 2(1) and (2), 3, 4, 5, 32, 35, 45, 46, 49, 53, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and the Traffic Management Act 2004 (the Act of 2004) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This Order shall come into operation on 2025 and may be cited as the Lincolnshire County Council (Heckington – St Andrews Street and Church Street) (Prohibition of Waiting) Amendment Order 2025
2. The Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 Plans including the key (the 'Plans') are incorporated into this Order.
3. Plan ? of the Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 shall be amended.
4. Any restriction or requirement made or having effect as if made under the Act of 1984 or any other enactment is hereby revoked insofar as it relates to the length and sides of road specified in this Order.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

STATEMENT OF REASONS

- Church Street
Investigations have shown that inconsiderate and dangerous parking is occurring causing visibility and safety concerns for all road users. The existing No Waiting Mon-Sat 8am-6pm on the south side of Church Street allows cars to double park outside these times which can lead to an obstruction to traffic flow and access concerns for emergency service vehicles. It is proposed to change this to No Waiting at Any time. Due to extending the No Waiting at Any Time to tie into St Andrews Street, we will revoke a small section of the new double yellow lines to give back some on street parking for the area.
- St Andrews Street
Investigations have shown that since the no waiting at any time restrictions on St Andrews Street have been implemented inconsiderate and dangerous parking is occurring at the narrowest point of the street causing safety concerns for all road users. To prevent an obstruction to the flow of traffic with vehicles parking inconsiderately the no waiting at any time restrictions will be extended on the north side of St Andrews Street right up to the junction of Church Street.
- Therefore, it is proposed to prohibit waiting as set out on the plans to the Order.
- The Chief Constable, Heckington Parish Council and North Kesteven District Council have been consulted, along with other local groups/companies.

LINCOLNSHIRE COUNTY COUNCIL (HECKINGTON – ST ANDREWS STREET & CHURCH STREET) (PROHIBITION OF WAITING) AMENDMENT ORDER 2025

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting as set out in the Schedule below:

- Extend the existing No Waiting at Any Time on St Andrews Street from property number 5 in a westerly direction to Church Street junction.
- Remove existing No Waiting at Any Time outside property numbers 61 and 71 Church Street.
- Introduce No Waiting at Any Time from St Andrews Street junction alongside the Church Wall and change the existing No Waiting Mon-Sat 8am-6pm on Church Street, which runs alongside the Church wall to No Waiting at Any Time.
- Introduce No Waiting at Any Time at the junction of Church Street and Cameron Street.

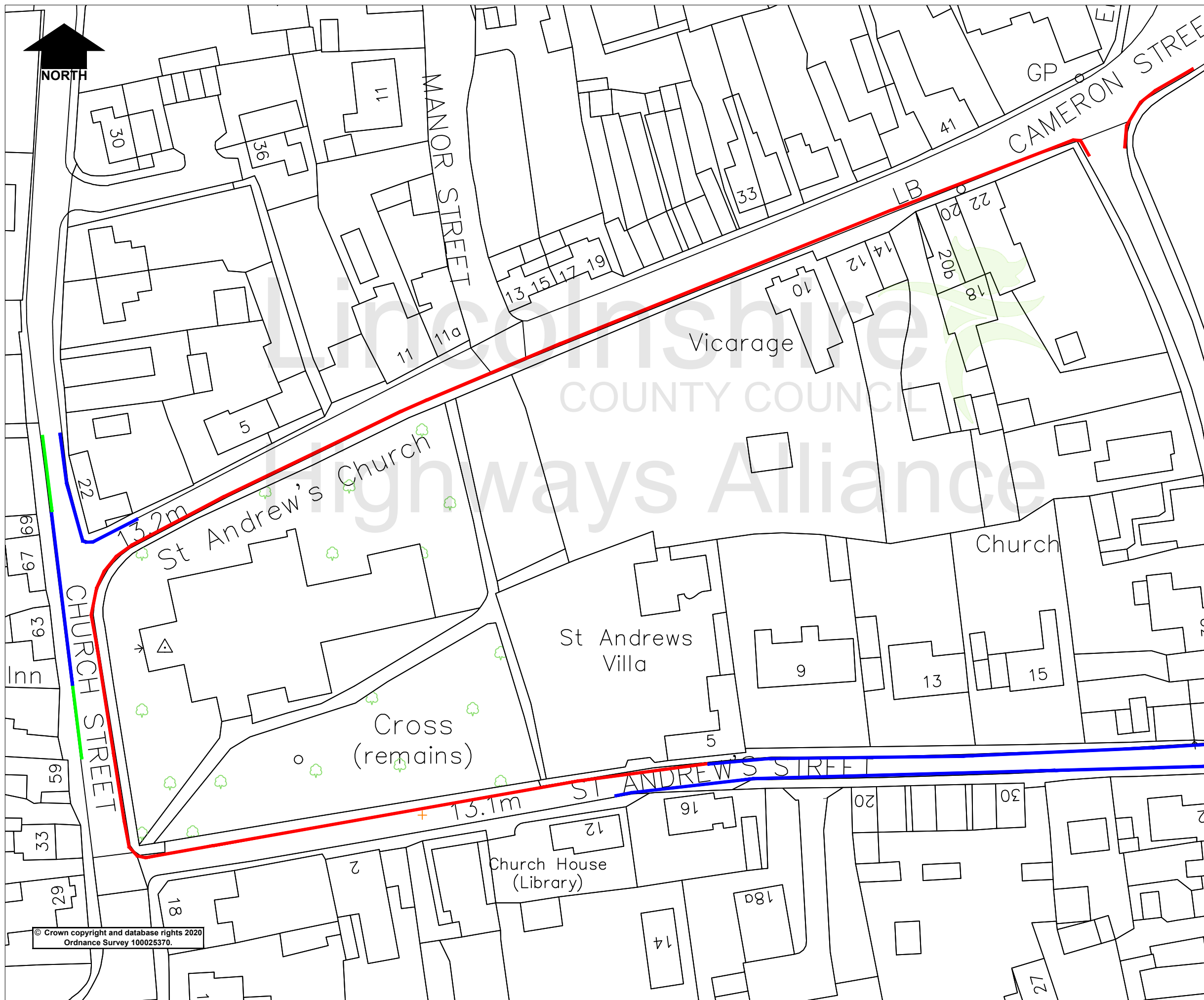
Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
