 (Prohibition of Waiting) Amendment Order 20
- The Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012
 Plans including the key (the 'Plans') are incorporated into this Order.
- Plan ? of the Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 shall be amended.
- 4. Any restriction or requirement made or having effect as if made under the Act of 1984 or any other enactment is hereby revoked insofar as it relates to the length and sides of road specified in this Order.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

LINCOLNSHIRE COUNTY COUNCIL (GAINSBOROUGH – SANDARS ROAD) (PROHIBITION OF WAITING) AMENDMENT ORDER 20 BUS STOP CLEARWAYS

STATEMENT OF REASONS

- Lincolnshire County Council recently received a request to review the waiting restrictions at the above location.
- Sandars Road is an industrial area and as such, must be able to accommodate multiple HGV manoeuvres in and out of the various units, it also forms part of a regular bus service.
- At present, vehicles are parking in such a manner that makes such manoeuvres difficult with some HGVs being forced to mount the verges in order to access some units. The concentration of parked vehicles in the centre of Sandars Road also hinders traffic flow and restricts visibility.
- To alleviate this, it is proposed to introduce a 'No Waiting at Any Time' restriction in a number of locations to ensure accesses/junctions are kept clear.
- It is appreciated that not all units have the capacity to support staff parking, therefore the proposal allows for some on-street parking to still take place.
- Therefore, it is proposed to prohibit waiting as set out on the plans to the Order.
- The Chief Constable, Gainsborough Town Council and West Lindsey District Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to prohibit waiting at various points along Sandars Road and establish Bus Stop Clearways on the existing bus stops.

Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
