

Notice of landowner deposits under section 31(6) of the Highways Act 1980 and section 15A(1) of the Commons Act 2006

Applications to deposit a highways statement and lodge a highways declaration under section 31(6) of the Highways Act 1980 and deposit a landowner statement under section 15A(1) of the Commons Act 2006 have been made in relation to the land (or lands) described below and shown pink/magenta on the accompanying map.

These deposits may affect rights over the land described below. Deposits made under section 31(6) of the Highways Act 1980 may prevent deemed dedication of public rights of way over such land under section 31(1) of that Act. Deposits made under section 15A(1) of the Commons Act 2006 may affect the ability to register such land as a town or village green under section 15 of that Act. 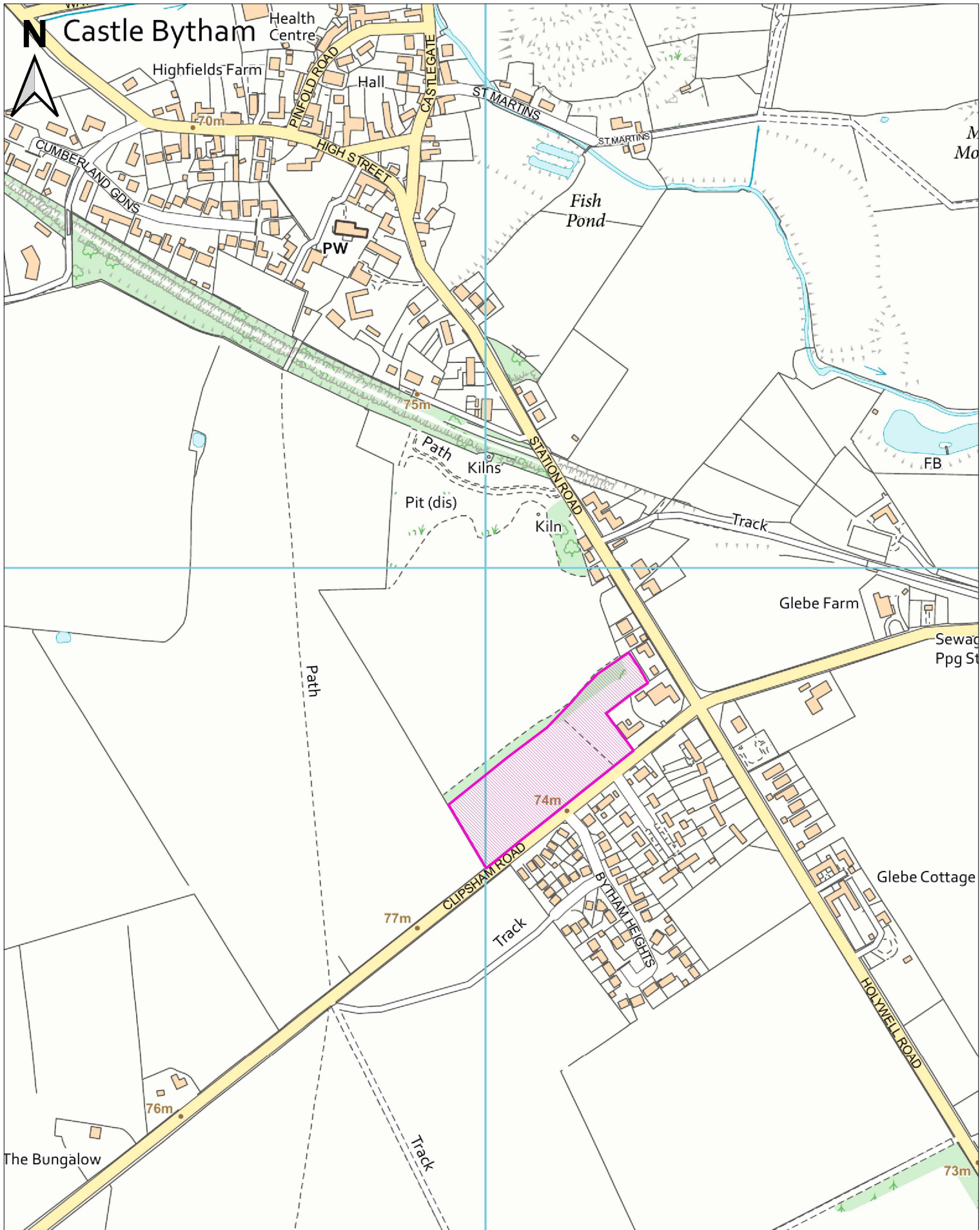
