The effect of the Order as confirmed is to divert the whole width of Public Footpath No.77 in the parish of Waddingham running from Clay Lane at OSGR SK 9875 9660 (A) in a generally westerly direction for approximately 59m to terminate at OSGR SK 9869 9660 (B). The total length of footpath diverted is approximately 59m as shown between points A-B on Order plan numbered 2024/011/PPO380/A4. TO AN ALTERNATIVE ROUTE in the parish of Waddingham to be 2 metres wide running from Clay Lane at OSGR SK 9875 9660 (A) in a generally west north westerly direction for approximately 17m to OSGR SK 9874 9661 (C) then continuing in a generally west south westerly direction for approximately 43m to terminate at OSGR SK 9869 9660 (B). The total length of footpath added is approximately 60m as shown between points A-C-B on Order plan numbered 2024/011/PPO380/A4.

- The public right of way over the land situate at Waddingham and shown by
  a bold continuous line on the plan contained in this Order and described in
  Part 1 of the Schedule to this Order shall be stopped up after 28 days from
  the date of confirmation of this Order.
- 2. There shall at the end of 28 days frown the date of confirmation of this Order be a public footpath over the land situate at Waddingham described in Part 2 of the Schedule and shown by a bold broken line on the plan contained in this Order.

The total length of footpath diverted is approximately 59m as shown between points A-B on annexed plan numbered 2024/011/PPO380/A4.


#### Description of site of new path/ way

The total length of footpath added is approximately 60m as shown between points A-C-B on annexed plan numbered 2024/011/PPO380/A4.
