

ROAD TRAFFIC REGULATION ACT 1984

LINCOLNSHIRE COUNTY COUNCIL

(HARLAXTON - SWINEHILL)

(PROHIBITION OF WAITING) AMENDMENT ORDER 20

THE LINCOLNSHIRE COUNTY COUNCIL in exercise of its powers under Sections 1, 2(1) and (2), 3, 4, 5, 32, 35, 45, 46, 49, 53, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and the Traffic Management Act 2004 (the Act of 2004) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This Order shall come into operation on 20 and may be cited as the Lincolnshire County Council (Harlaxton - Swinehill) (Prohibition of Waiting) Amendment Order 20
2. The Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 Plans including the key (the 'Plans') are incorporated into this Order.
3. Plan ? of the Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 shall be amended.
4. Any restriction or requirement made or having effect as if made under the Act of 1984 or any other enactment is hereby revoked insofar as it relates to the length and sides of road specified in this Order.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

STATEMENT OF REASONS

- Lincolnshire County Council recently received a request to review the waiting restrictions in the vicinity of Harlaxton Primary School.
- Investigations have shown that the advisory School Keep Clear markings are often not observed and that turning movements in and out of the school and doctors surgery are often difficult because of parked vehicles at peak drop off and pick up times.
- It is proposed to make the School Keep Clear marking mandatory Mon to Fri between the hours of 8 to 9.30am and 2.30 to 4pm. Waiting will also be prohibited between these times opposite the school entrance and doctors surgery to ensure access is maintained.
- It is also proposed to prohibit waiting 24 hours a day directly in the school access to ensure the school transport service has access at all times.
- Therefore, it is proposed to prohibit waiting as set out on the plans to the Order.
- The Chief Constable and South Kesteven District Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to establish mandatory school keep clear markings and no waiting between the hours of 8 to 9.30am and 2.30 to 4pm, Monday to Fri, in the vicinity of the Primary School and Doctors Surgery. No Waiting at Any Time will also apply to the entrance to the school.

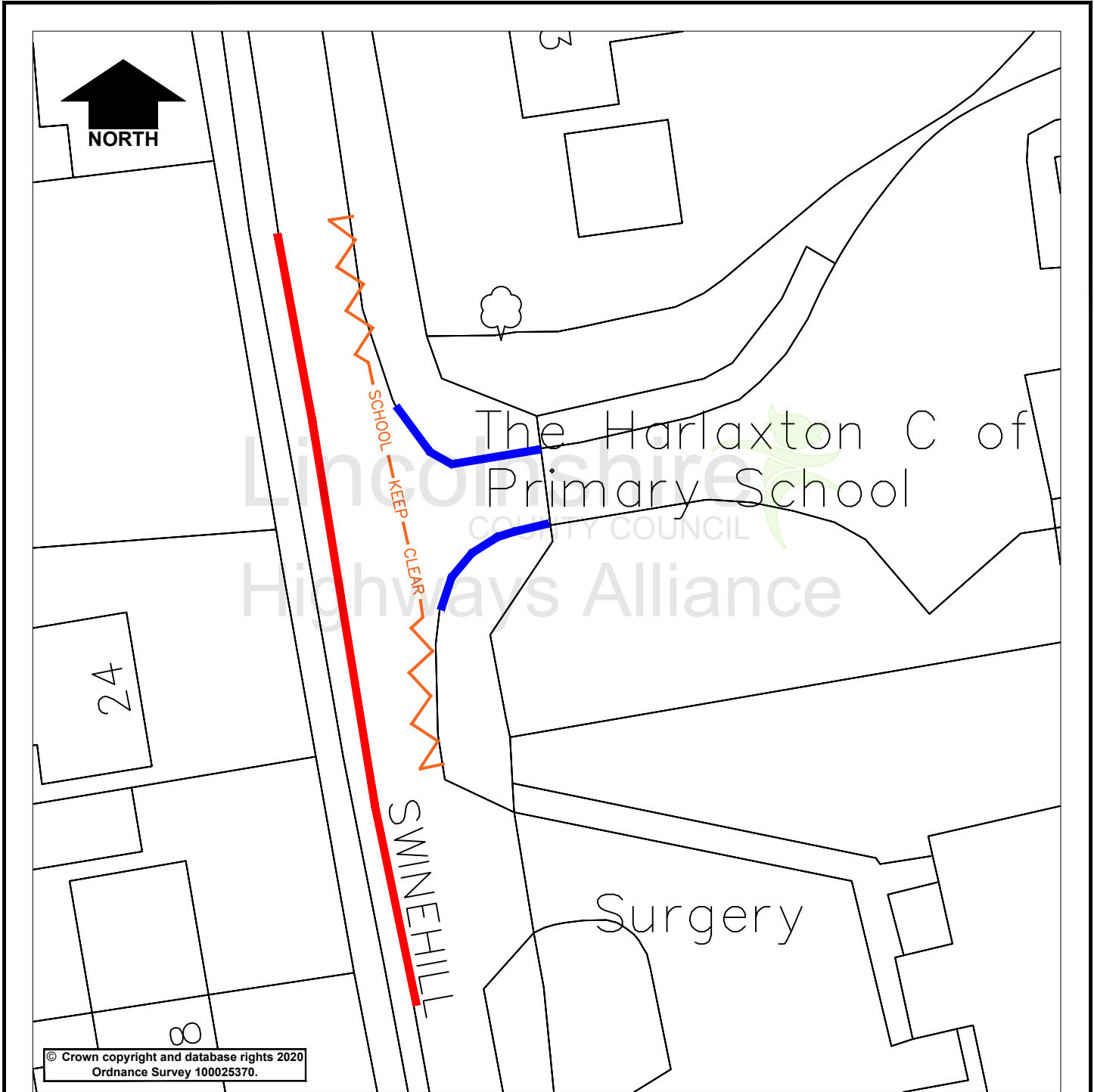
Exemptions are included which will permit waiting for disabled persons' vehicles and for the purpose of picking up or setting down passengers, loading or unloading of goods, the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.
