

ROAD TRAFFIC REGULATION ACT 1984

LINCOLNSHIRE COUNTY COUNCIL

(SLEAFORD, STATION ROAD)

(PROHIBITION OF WAITING) AMENDMENT ORDER 20

THE LINCOLNSHIRE COUNTY COUNCIL in exercise of its powers under Sections 1, 2(1) and (2), 3, 4, 5, 32, 35, 45, 46, 49, 53, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and the Traffic Management Act 2004 (the Act of 2004) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. This Order shall come into operation on 20 and may be cited as the Lincolnshire County Council (Sleaford Station Road) (Prohibition of Waiting) Amendment Order 20
2. The Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 Plans including the key (the 'Plans') are incorporated into this Order.
3. Plan ? of the Lincolnshire County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2012 shall be amended.
4. Any restriction or requirement made or having effect as if made under the Act of 1984 or any other enactment is hereby revoked insofar as it relates to the length and sides of road specified in this Order.

5. The prohibition imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

STATEMENT OF REASONS

- Lincolnshire County Council recently received a request to review the waiting restrictions at the above location with a view to providing a loading facility to local businesses.
- Investigations have shown that the existing taxi rank on the north side of Station Road is underused during the day, and it would be beneficial to local businesses to have an area dedicated for the loading of goods. Therefore, we are proposing to change this area to loading only from 7am to 5pm, with the section resorting back to a taxi only zone from 5pm to 7am.
- It was also noticed that the existing Bus Stop area on the southern side of Station Road does not currently have a traffic regulation order behind it, so we are also proposing to formalise this amenity.
- Therefore, it is proposed to prohibit waiting as set out on the plans to the Order.
- The Chief Constable, Sleaford Town Council and North Kesteven District Council have been consulted, along with other local groups/companies.

NOTICE IS HEREBY GIVEN that the Lincolnshire County Council propose to make an Order under their powers contained in the Road Traffic Regulation Act 1984, the effect of which will be to introduce a bus stop clearway daily 7am-7pm at the existing bus stop layby, change the existing no stopping except taxis opposite the bus stop layby to loading only 7am-5pm and no stopping 5pm-7am except taxis.

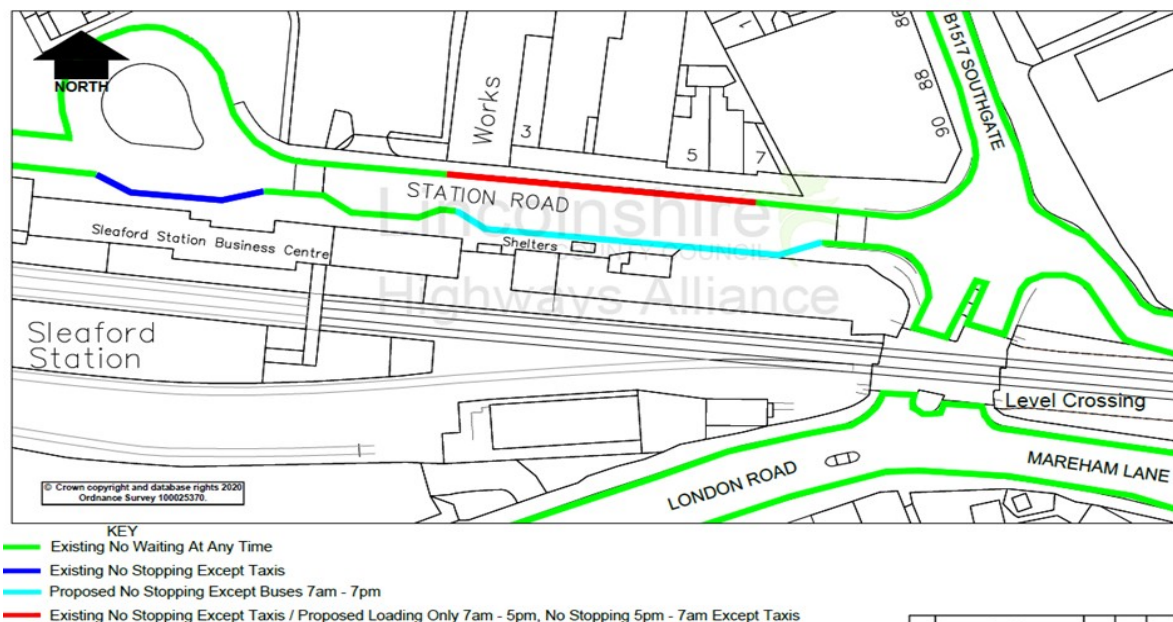
Exemptions are included which will permit the maintenance of the roads, and works in connection with the supply of gas, electricity, water and telecommunications apparatus.

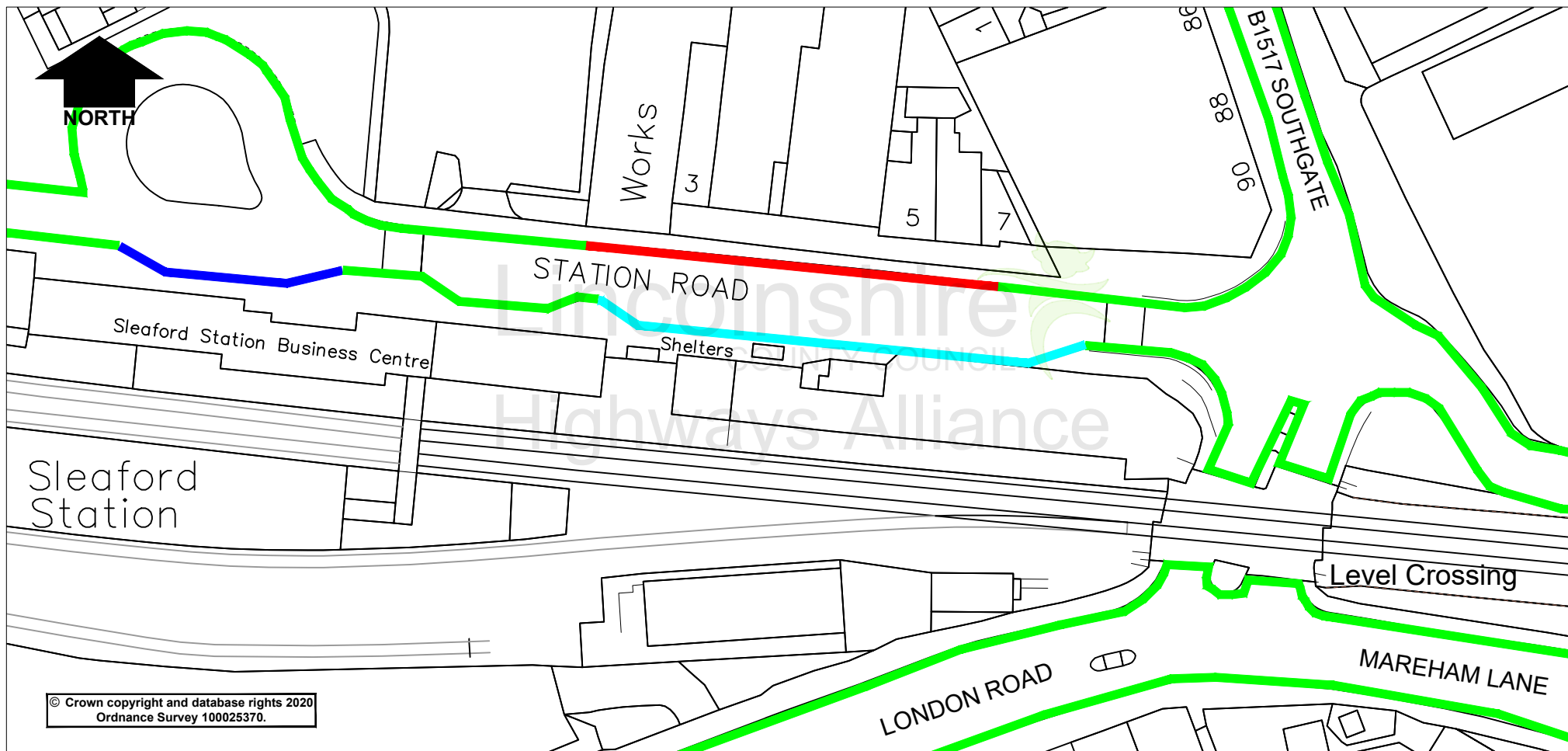
