On 19 May 2025 Lincolnshire County Council confirmed the above-named Order. The effect of the Order as confirmed is to divert the whole width of Boothby Pagnell Public Footpath 4 running from OSGR SK 9840 2950 (A) in a generally north westerly direction for approximately 372 metres to OSGR SK 9818 2979 (B) then continuing in a generally west north westerly direction for approximately 506 metres to terminate at an unaffected part of Public Footpath 4 at OSGR SK 9775 3004 (C). The total length of footpath diverted is approximately 878 metres as shown between Points A-B-C on Order Plan No. 2024/016/PPO385/A3(rev1). Also the whole width of Boothby Pagnell Public Footpath 4 running from OSGR SK 9766 3026 (F) in a generally north westerly direction for approximately 510 metres to terminate at the B1176 at OSGR SK 9737 3068 (G). The total length of footpath diverted is approximately 510 metres as shown between Points F-G on Order Plan No. 2024/016/PPO385/A3(rev1) TO AN ALTERNATIVE ROUTE in the parish of Boothby Pagnell to be a 2 metre wide public footpath running from OSGR SK 9840 2950 (A) in a generally north north westerly direction for approximately 351 metres to OSGR SK 9829 2982 (D) then continuing in a generally west north westerly direction for approximately 438 metres to OSGR SK 9792 3005 (E) then running in a generally westerly direction for approximately 169 metres to terminate at an unaffected part of Public Footpath 4 at OSGR SK 9775 3004 (C). The total length of footpath added is approximately 958 metres as shown between Points A-D-E-C on Order Plan No. 2024/016/PPO385/A3(rev1). Also a 2 metre wide public footpath running adjacent to West Glen River from OSGR SK 9766 3026 (F) in a generally north westerly direction for approximately 403 metres to OSGR SK 9737 3053 (H) then continuing in a generally northerly direction for approximately 176 metres to terminate at the B1176 at OSGR SK 9736 3068 (J). The total length of footpath added is approximately 579 metres as shown between Points F-H-J on Order Plan No. 2024/016/PPO385/A3(rev1).

The Order comes into force as from 16 June 2025 but if a person aggrieved by the Order desires to question its validity, or of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within six weeks from 6 June 2025 make an application to the High Court.
