## **Terms and Conditions**

- 1. Entrants into the educational art competition shall be deemed to have accepted these Terms and Conditions and to comply fully with them
- 2. All entrants must be aged 11 to 16 years of age
- 3. For the educational art competition, you must have permission to enter from your parent or guardian. You must confirm your parent or guardian has read and agreed to these terms and conditions, and the relevant consent form must be completed and submitted alongside the artwork. A parent or guardian can also submit an entry on behalf of young creatives, but the consent form must still be completed and submitted. The Council reserves the right to exclude entries where this is not given
- 4. Your, or your parent or guardian, can submit original or digital artwork to this competition by:

  - c. Entries can be brought to the Council Offices at Kesteven Street and the Hub (North Kesteven District Council Reception is open 9am 5pm, Monday through to Wednesday, closed between 1pm 2pm for lunch, and the Hub is open 10am 5pm, Monday through to Saturday, and 10am 4pm Sunday and Bank Holidays.
  - d. The consent form must be completed by your parent or guardian when you submit your entry
- 5. Entrants are not permitted to withdraw previously submitted entries and attempts to replace entries with newer submissions is not allowed
- Entries can be created in any form of media, for example photography, mosaic, cake, collage, sculpture, textile or hand drawn media. They can be 2D or 3D, but please be mindful that 3D items may need more consideration around submission and delivery
- 7. By submitting their entry, each participant confirms and warrants that:
  - They are the sole author of each entry and it is their original work
  - They own the copyright and any other intellectual property rights
  - They have the permission of anyone pictured in the image (or, where the image shows any person under the age of 18, the consent of their parent or guardian)
- 8. Entry to the educational art competition are restricted to one entry per person
- 9. Personal contact details will be used for the purpose of administering the competition
- 10. Your child's name, age, brief description of their entry and how it reflects them as an individual may be published to credit them with taking part in the educational art competition. This could be published in Council promotional activities and materials including, but not limited to, digital social media, website, printed communications, press coverage and other such uses. We may also send them to the news media
- 11. The educational art competition will run from 9am on Wednesday 13 December to 12noon on Wednesday 17 January 2024. All entries must be submitted by the closing date and any entries received after this date will not be considered

- 12. The Council accepts no liability or responsibility for entries that are lost, mislaid, damaged, delayed or undelivered, regardless of cause, including (without limitation), for example, equipment failure, technical malfunction, network/server/computer hardware or software error. The Council does not accept any liability for technical errors or communication failures in networks and/or internet access. - 13. Copyright in all images submitted for this competition remains with the respective entrants. However, by entering this competition, the entrant grants irrevocable permission to the Council to use in their promotional activities and materials including, but not limited to, digital social media, website, printed communications, press coverage and other such uses. We may also send them to the news media
- 14. The Council will not accept proof of transmission as proof of receipt of entry to the educational art competition
- 15. Unsuccessful entrants will not be contacted and there is no obligation to feedback on any entry
- 16. Entries will be shortlisted by Sleaford-based illustrative artist, Ruth Burrows, and North Kesteven District Council Leader, Councillor Richard Wright. A range of shortlisted entries will be showcased in a collated space at the Hub, Sleaford from Saturday 27 January 2024 to Saturday 3 February 2024, where visitors will be able to nominate their favourite(s). They may also be publicised via Facebook where people can vote/nominate their favourite(s). - 17. Winners will be announced on Wednesday 7 February 2024 with prizes awarded to winning entries
